A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE VICTOR MA. REGIS N. SOTTO, TO ENTER INTO AND SIGN A TERMS OF PARTNERSHIP BETWEEN THE DEPARTMENT OF HEALTH - METRO MANILA CENTER FOR HEALTH DEVELOPMENT (DOH-MMCHD) AND THE LOCAL GOVERNMENT OF PASIG CITY, AND FOR OTHER PURPOSES.

WHEREAS, Section 11, Article XIII of the 1987 Philippine Constitution provides, among others, that the State shall adopt an integrated and comprehensive approach to health development, which shall endeavor to make essential goods, health and social services available to all people at affordable cost;

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates the devolution of the delivery of health services and facilities as one of the basic functions and responsibilities of all local government units (LGUs) at all levels;

WHEREAS, Executive Order No. 138, Series of 2021, further reinforced the State's policy of full devolution of certain functions, services and facilities from the national government to LGUs;

WHEREAS, the Supreme Court in the case of *Mandanas, et al. v. Executive Secretary, et al.* upheld the principle that the collection of national taxes, subject to certain exceptions, shall form part of the LGU's National Tax Allotment to further emphasize the policy of full devolution to the LGUs;

WHEREAS, Section 22 of Republic Act No. 11223, otherwise known as the Universal Health Care Act, directs the national government to make available commensurate financial and non-financial matching grants, including capital outlay, human resources for health and health commodities, to improve the functionality of province-wide and city-wide health systems, provided that the grants shall be in accordance with the approved province-wide and city-wide health investment plans, which shall account for complementation of public and private health care providers and public or private health sector investments;

WHEREAS, the City Government of Pasig has agreed to implement health sector reforms consistent with the Universal Health Care Act and has proven its capacity to utilize investment and sustain the reform process of its health sector;

WHEREAS, the Local Investment Plan for Health (LIPH) is the medium term public investment planning for health undertaken by the LGUs in partnership with the Department of Health (DOH) to carry out health reforms within their jurisdictions and is later on implemented through an Annual Operation Plan (AOP);

WHEREAS, the City of Government of Pasig has prepared its 2023-2025 LIPH, and 2023 AOP as reviewed by the city and the Department of Health – Metro Manila Center for Health Development (DOH-MMCHD) Appraisal Committee, and modified based on their respective recommendations;

WHEREAS, by way of formalizing and confirming the commitment of the City Government of Pasig and the DOH-MMCHD, the parties hereby agree to enter into a Terms of Partnership;



The Committee on Health, Sanitation and Nutrition conducted a Committee Hearing on February 13, 2023, 2:00 o'clock in the afternoon at the Gallery, Session Hall, 7/F Pasig Cityhall, to discuss the pertinent provisions of Resolution No. 167, Series of 2023 entitled: "A Resolution Authorizing the City Mayor, Honorable Victor Ma. Regis N. Sotto, to Enter Into and Sign A Terms of Partnership Between the Department of Health-Metro Manila Center for Health Development (DOH-MMCHD) and the Local Government of Pasig City, and for Other Purposes".

The Committee Hearing was attended by Councilor Roderick Mario U. Gonzales, Councilor Marion Rosalio Martires, Councilor Raymund Francis Rustia, Councilor Paul Roman Santiago, Councilor Quin Cruz, Councilor Mark Gil Delos Santos, Councilor Maria Luisa de Leon, and Councilor Noel Agustin.

As resource persons, the hearing was attended by Mr. Jaia Ebuena from the DOH, Dr. Joselito Morete from Child's Hope, Mr. Dave Basaca of the Health Department of Pasig, Mr. Mario Roldan from the Mayor's Office and representative of Dr. Castro from Pasig City General Hospital.

During the above-mentioned Committee Hearing the following were discussed:

1. As explained by Mr. Jaia Ebuena, this Terms of Partnership was designed to institutionalize the partnership of DOH and Pasig LGU for the full implementation of the Universal Health Law of the National Government;
2. It was also mentioned by Mr. Ebuena that the provisions, terms and conditions of this partnership were all in operation for a long time already and this terms of partnership is in compliance with the requirement of the Universal Health Care Law;
3. The Councilors manifested their request to the DOH for additional funding for our hospitals, particularly for Pasig City General Hospital since our hospitals cater not only to Pasiguenos but also to neighboring Municipalities of Rizal, due to proximity;
4. The Councilors present, as well as Doctors of our health facilities expressed their gratitude for this partnership and gives assurance that the Pasig LGU and the DOH will continue to support the campaign for a healthier Pasiguenos.
