**WHEREAS**, this conference will allow them to get acquainted with the new trends in education, research, forge collaboration with researchers, and a chance to present their research to the international education community;

**WHEREAS**, providing support to them can significantly help in boosting their morale as they will face the challenges during the participation, knowing that the City Government is behind them.

**NOW, THEREFORE**, on a motion duly seconded, the Sangguniang Panlungsod resolves, as it hereby resolved, to authorize the City Mayor, Honorable Victor Ma. Regis N. Sotto, to grant financial assistance to Ms. Lovely Rollaine B. Cruz and Ms. Catherine Jane A. 



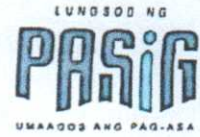

The hearing was presided concurrently primarily by the Chair of the Committee on Education and the Chair of Appropriations, Ways and Means.

#### The Discussion

1. The meeting was held after the proponents returned from their successful (1) research paper presentation entitled "Improving Elementary Learners' Research Writing Skills Through Modified Scaffolding Research Guide: A Process Research Genre Approach" at the 2023 Southeast Asian Conference on Education and (2) completion of their visit at the Tampines Primary School which is one of the few schools which offers research writing subject at the primary grades.
2. It is worth noting that the discussion was lively and productive inasmuch as many new information were shared which are useful and can be applied in the education system of the city such as:
  - a. First, the research conducted has also been tested in Pinagbuhatan Elementary School and initial findings were encouraging for both students and parents
  - b. Elementary pupils, with the proper guidance and adequate mentoring can follow instructions and produce research outputs.
  - c. There were no final conclusions though on whether the research results will be applied or used inasmuch as it is still in the experimental stage and no conclusive statements can be made yet.
  - d. It was noted though that the financial request by the proponents will be put to good use and therefore deserved to be granted;
3. The visit to the Tampines Primary School further affirmed that indeed research skills can be developed already among young students in the primary grades.
4. The discussion noted that the results of the works of the requesters for financial aid convinced the participants of the hearing that indeed the initial talks about establishing a Pasig City Science Elementary School can be further pursued.

#### Decisions and Recommendations

1. There were no objections to the approval of the requested amount of financial assistance.
2. Title - It is recommended that the phrase "to be divided proportionately" in the title be amended to "divided equally."

**APPROVED** this report of the Joint Committee and endorsing the same report for approval to the 11<sup>th</sup> Sanggunian during its regular session on February 27, 2023. Following the rules and procedure of the Sanggunian, submit a motion for approval on second and third reading.


