SOTTO, TO GRANT FINANCIAL ASSISTANCE TO THIRTY-FIVE (35) PROSECUTORS OF PASIG CITY IN THE AMOUNT OF ONE MILLION FIFTY THOUSAND PESOS (PHP 1,050,000.00), WHERE EACH AND EVERY PROSECUTOR WILL RECEIVE THE AMOUNT OF THIRTY THOUSAND PESOS (PHP 30,000.00), TO HELP DEFRAY THE COST OF THEIR PARTICIPATION IN THE 32<sup>ND</sup> NATIONAL CONVENTION OF THE PROSECUTOR'S LEAGUE OF THE PHILIPPINES, INC. TO BE HELD ON MARCH 27 TO 31, 2023, AT THE SMX CONVENTION CENTER, SM LANANG, DAVAO CITY, AND FOR OTHER PURPOSES.

**WHEREAS**, the 32nd National Convention of the Prosecutor's League of the Philippines, Inc. will be held on March 27 to 31, 2023, at the SMX Convention Center, SM Lanang, Davao City with the theme "Prosecutors: Vanguard of Truth, Justice and Freedom". The event will be attended by approximately thirty five (35) of the Pasig City Prosecutors who will be representing the honor and pride of Pasig;

**WHEREAS**, thirty-five (35) prosecutors of Pasig City who will be attending the said convention sought for financial assistance from the City Government of Pasig for their participation in the said convention;

**WHEREAS**, the City Government of Pasig acknowledges the indispensable role of the prosecutors in administering justice and ensuring that laws are complied with, and deems it meritorious to hereby grant financial assistance to them in the amount of Thirty Thousand Pesos (Php 30,000.00) each to help defray the cost of their participation in the said convention;

**NOW, THEREFORE**, on session duly assembled, the Sangguniang Panlungsod, resolves, as it is hereby resolved, to authorize the City Mayor, Honorable Victor Ma. Regis N. Sotto, to grant financial assistance to Thirty-Five (35) Prosecutors of Pasig City in the amount of One Million Fifty Thousand Pesos (Php 1,050,000.00), where each and every prosecutor will receive the amount of Thirty Thousand Pesos (Php 30,000.00), to help defray the cost of their participation in the 32nd National Convention of the Prosecutor's League of the Philippines, Inc. to be held on March 27 to 31, 2023, at the SMX Convention Center, SM Lanang, Davao City.

**RESOLVED, FURTHERMORE**, that the budgetary requirement to implement this Resolution shall be chargeable against any available funds in the City Treasury, subject to existing COA rules and regulations.

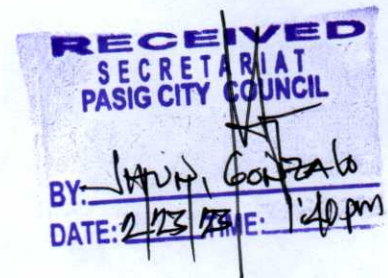

Mr. Presiding Officer and Members of the 11<sup>th</sup> Sangguniang Panlungsod the Committee on Peace & Order, Human Rights, Judicial Matters and Anti-Drug Abuse respectfully presents & renders the Committee Report on the Committee hearing conducted last February 20, 2023 at the Gallery Hall of Session Hall, 7<sup>th</sup> floor Pasig City Hall.

### **The Committee Reports:**

The Committee Chairperson acknowledges and extends his gratitude for the presence of the Honorable Members of the Judiciary Department under the City Government of Pasig which composed of Presiding Judges, City Prosecutors, Clerk of Courts, and Court Sheriffs for the said committee hearing.

City Prosecutor Honorable Rey Camilo Dumlao II was given the floor to manifest his statements regarding the proposed Resolution where he narrated a short history of the said request for Financial Assistance or allowances to defray the costs of their participation in the 32<sup>nd</sup> National Convention of the Prosecutors League in Davao City. In his manifestation, it was mentioned that it will be an honor for the City Prosecutors to join the said convention as they will definitely represent the City with full pride and honor.

Their request for financial assistance from the City to defray the costs is because not everyone can afford to participate with the said convention due to the expenses and seeking assistance from the city was their option in order to have every prosecutor of the City to participate with the said convention as this activity is required by the Department of Justice (DOJ). Honorable Dumlao II mentioned that their performance and credentials where one of the awards stated is that the Office of the City Prosecutor of Pasig was able to be awarded as one of the City Prosecutors who has the most efficient disposition of Cases where they were awarded as Top 1.

Committee Chairperson delos Santos clarified the figures from the Honorable Prosecutor Dumlao II whereas there was a correction in the total amount of cash assistance and number of prosecutors that will receive financial assistance to be granted by the City Government from 30 prosecutors to 35 with a grand total of Php.1,050,000.00. The said amount was confirmed by Atty. Tomic Apacible from the Office of the City Administrator.

Members of the Committee manifested their support towards the request of the Office of the City Prosecutor where Minority Floor Leader & Committee Vice Chairperson Maria Luisa de Leon expressed her gratitude to the performance of the City Prosecutors where it was indeed applaudable and their request is just a small amount to their contribution and service to their clients. This was seconded by Presiding Officer Pro Tempore Councilor Raymundo PhD. Where she congratulated the

Prosecutors for the awards and recognitions they received throughout their tenure as City Prosecutors and suggested that their good office might help the Gender & Development (GAD) Development will be enhanced more through the help of their office by providing speakers that can speak about Violence Against Women & Children (VAWC). This was supported by Honorable Dumlao II where he mentioned that their office will definitely coordinate with Councilor Raymundo's office regarding that request.

The Committee Chairperson, Majority Floor Leader delos Santos reiterated the salient points of the committee hearing and moves to adopt the minutes of the meeting & the amendments of the said resolution which corrected the number of Prosecutors to be beneficiaries that will receive Php. 5,000 from 30 to 35 and with a total amount of Php. 1,050,000.00.


#### **Summary of Discussions**

- The Office of the City Prosecutor will have 35 attendees for the said event and will receive Php.30,000.00 each amounting to a total of Php.1,050,000.00.


#### **Recommendations**


