WHEREAS, on May 24 to 26, 2023, the 21st National Convention and Election of Officers of SCOPHIL is slated to be held in General Santos City, South Cotabato as per Office of the Court Administrator Circular No. 307-2022;

WHEREAS, there are Thirty-Three (33) Sheriffs of Pasig City from the MeTC and RTC, who intend to attend the said national convention considering the lectures, updated jurisprudence and circulars that will be discussed therein that will improve their legal knowledge;

WHEREAS, the said MeTC and RTC sheriffs of Pasig City sought for financial assistance from the City Government of Pasig for their participation in the said national convention;

WHEREAS, the City Government of Pasig acknowledges the indispensable role of Sheriffs in the administration of justice, and deems it meritorious to hereby grant financial assistance to each sheriffs the amount of Ten Thousand Pesos (Php 10,000.00) to help defray the cost of their participation in the said national convention;

NOW, THEREFORE, on session duly assembled, the Sangguniang Panlungsod, resolves, as it is hereby resolved, to authorize the City Mayor, Honorable Victor Ma. Regis N. 

Mr. Presiding Officer and Members of the 11th Sangguniang Panlungsod Committee on Peace & Order, Human Rights, Judicial Matters and Anti-Drug Abuse respectfully presents & renders the Committee Report on the Committee hearing conducted last February 20, 2023 at the Gallery Hall of Session Hall, 7th floor Pasig City Hall.

The Committee Reports:

The Sheriffs of the Courts of Pasig requested financial assistance to the City Government of Pasig for their participation in the 21st National Convention & Election of Officers of Sheriffs Confederation Of the Philippines on May 24-26 2023 at General Santos City.

Mr. Edwin Estella, representative of the Court Sheriffs in Pasig manifested their inputs regarding their request where they are only requesting a financial assistance that will help defray the costs of their airfare, registration and hotel accommodation.

Chairperson delos Santos inquired on how many sheriffs to the Pasig Court has. It was identified through the response of Mr. Estella that there are 35 Sheriffs but only 33 will pledged to attend the said event.


Summary of Discussion

- There are only 33 Sheriffs that will attend the 21st National Convention & Election of Officers of Sheriffs Confederation of the Philippines
- Each Sheriff will receive Php.10,000 cash assistance from the City Government of Pasig.


