COMMITTEE REPORT

The initial hearing was held on February 24, 2023 at Gallery Session Hall, 7th Floor, Pasig City Hall, in the presence of majority of the members of the Committee on Appropriations, Ways and Means and Committee on Sports, together with Mr. Aaron Salandanan, Basketball Coach, Ms. Mary Anne Toledo from the Local Youth Development Office; and Ms. Jonalynn Badillo from the City Budget Office to discuss Proposed Resolution 174-2023: A Resolution Authorizing The Honorable City Mayor, Victor Ma. Regis N. Sotto, To Grant Financial Assistance In The Amount Of Three Hundred Sixty Thousand Eight Hundred Pesos (P 360,800.00) To The Pasig City Grassroots – Basketball Team (Uprise), For Their Participation In The National Youth Basketball League And United Basketball League On March And April 2023, And For Other Purposes, which was referred to the committee during the Regular Session held February 16, 2023.

After a careful study and discussion, the following were finalized:

1. As presented by Councilor Marion Rosalio Martires, Proposed Resolution 174-2023: A Resolution Authorizing The Honorable City Mayor, Victor Ma. Regis N. Sotto, To Grant Financial Assistance In The Amount Of Three Hundred Sixty Thousand Eight Hundred Pesos (P 360,800.00) To The Pasig City Grassroots – Basketball Team (Uprise), For Their Participation In The National Youth Basketball League And United Basketball League On March And April 2023, And For Other Purposes.
2. 2 tournaments, United Basketball League (UBL) and National Youth Basketball League (NYBL) will be participated in by 1 and 2 teams of 15 players, respectively. With players from Pasig City Elementary and High Schools and Out of School Youth.
3. The PHP 360,800 is divided for both tournaments, with PHP 140,000 allotted for the UBL team, PHP 104,800 allotted for the NYBL 17 under team, and PHP 116,000 allotted for the NYBL 13 under team. The budget is allotted for food, transportation, uniforms, coaches' allowance, and tournament fees.
4. The Committee recommends that this report be adopted, and the Proposed Resolution 174-2023 be duly passed on its' second reading in the next regular session, March 6, 2023.
