A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, VICTOR MA. REGIS N. SOTTO TO GRANT FINANCIAL ASSISTANCE TO FOUR (4) INFORMAL SETTLER FAMILIES OF E. SANTOS ST., BRGY. PALATIW, PASIG CITY, DUE TO THEIR DISPLACEMENT BY VIRTUE OF A COURT ORDER.

WHEREAS, the four (4) informal settler families are located at e. Santos St., Brgy. Palatiw, are subject of judicial proceedings, wherein the court ordered, with finality, that they should vacate the subject property;

WHEREAS, the said informal settler families have been duly validated by the City Social Welfare and Development Office as underprivileged and homeless, as defined in RA 7279 or the Urban Development and Housing Act of 1992 (UDHA);

WHEREAS, in coordination with the Pasig Urban Settlements Office ("PUSO"), these informal settler families are invoking the provisions of the UDHA and are requesting assistance from the local government;

WHEREAS, to ease the burden of the members of the community, and to aid them during this time of pandemic, the City Government of Pasig deems it necessary to grant financial assistance to them based on the provisions of the UDHA;

NOW, THEREFORE, on motion duly seconded, the City Council resolves, as it is hereby resolved, to grant financial assistance in the amount of Thirty-Four Thousand Two Hundred Pesos (Php 34,200.00) each, equivalent to the prevailing minimum wage times sixty (60) days, to comply with the provisions of the UDHA for the structure owners, namely: MA. JENNIFER F. ODONZO; JOHN EARL F. ODONZO; GLORIA L. FORTADES and MARY ROSE FORTADES due to their displacement.

RESOLVED FINALLY, that the budgetary requirement to implement this Resolution shall be chargeable against any available funds in the City Treasury, subject to existing COA rules and regulations.
