WHEREAS, Mevbuilt Inc. wishes to donate all its rights and interests in the subject properties to the City Government of Pasig for the purpose of helping and assisting the victims of Covid19;

WHEREAS, the said donation will undoubtedly benefit the constituents of the City Government of Pasig City in its fight against Covid19;

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod resolves, as it is hereby resolved, to authorize the Honorable City Mayor, Victor Ma. Regis N. Sotto, to enter into and sign a deed of donation between the City Government of Pasig and Mevbuilt Inc., for the donation of Two Hundred Twelve (212) Pieces of Wooden Doors.







COMMITTEE REPORT


The initial hearing was held on April 25, 2023 at the Session Hall, 7th Floor, Pasig City Hall, in the presence of majority of the members of the Committee on Appropriations, Ways and Means, together with Ms. to discuss **Proposed Resolution No. 208-2023 entitled A Resolution Authorizing The Honorable City Mayor, Victor Ma. Regis N. Sotto To Enter Into And Sign A Deed Of Donation Between The City Government Of Pasig And Mevbuilt Inc., For The Distribution Of Two Hundred Twelve (212) Pieces Of Wooden Doors, And For Other Purposes.** which was referred to the committee during the Regular Session held March 27, 2023.

After a careful study and discussion, the following were finalized:

1. Mevbuilt Inc., based in Quezon City has been in the construction industry for 10 years,
2. An inquiry was made by Coun. Rustia on whether the doors were eco-friendly. The representative from Mevbuilt Inc. assured the Committee that the doors were eco-friendly and of good quality.
3. The Committee recommends that this report be adopted, and the **Proposed Resolution No. 208-2023** be duly passed on its' second reading in the next regular session.


