SOTTO, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE DIABETES PHILIPPINES, INC., PHILIPPINE ASSOCIATION OF DIABETES EDUCATORS AND ASSOCIATION OF DIABETES NURSE EDUCATORS OF THE PHILIPPINES; ASTRAZENECA PHARMACEUTICAL (PHILS.), INC., KIDNEY TRANSPLANT ASSOCIATION OF THE PHILIPPINES, PHILIPPINE DIABETES SUPPORT AND DIALYSIS PHILIPPINES, AND FOR OTHER PURPOSES.

WHEREAS, Section 13, Article II of the 1987 Constitution provides that the State recognizes the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, intellectual, and social well-being. It shall inculcate in the youth patriotism and nationalism, and encourage their involvement in public and civic affairs;

WHEREAS, Section 15 thereof also provides that the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, under Section 23 thereof provided further that the State shall encourage non-governmental, community-based, or sectoral organizations that promote the welfare of the nation;

WHEREAS, Astrazeneca Pharmaceutical (Phils.), INC. proposes to implement the ACT NOW PROGRAM in Pasig City with the aim of addressing the progressively increasing complications from Type 2 Diabetes, Hypertension and Dyslipidemia in the Philippines, which includes cardiovascular and chronic kidney diseases. The program shall include: (1) the use of risk factor assessment and CKD questionnaire in the management of non-communicable diseases within the Local Government Unit of Pasig City (LGU) to identify patients at high risk of developing cardiorenal complications; (2) continuing medical education for health practitioners on risk factor management, including the use of the Risk Assessment tools; (3) Lay education on lifestyle modification, adherence to therapies and prevention of cardiorenal complications; and (4) establish a health hub with risk factor treatment pathway, participate in data generation, and provide access to treatment;

WHEREAS, the LGU of Pasig City shall identify the target institutions and healthcare facilities within its jurisdiction for the implementation and provide assistance in the implementation of the aforementioned program;

WHEREAS, the Philippine Association of Diabetes Educators and Association of Diabetes Nurse Educators of the Philippines shall serve as scientific experts and provide their expertise in the evaluation of the risk assessment tool, module development for medical education, and empower their members to be resource persons in educating the lay members of the LGU of Pasig;

WHEREAS, the Astrazeneca Pharmaceutical (Phils.), INC. shall provide the overall program coordination and logistics support, including: providing online platforms for events, continuing medical education and lay lecture events management, provision of risk assessment tools, and coordination and scheduling of events between the LGU of Pasig and Partner societies;

WHEREAS, the Kidney Transplant Association of the Philippines, Philippine Diabetes Support and Dialysis Philippines shall support the overall educational campaign as advocates of disease prevention by providing online platforms for events, webinars and other educational content materials, lay lecture events management, and coordination and scheduling of events between the LGU of Pasig City and Partner societies;



The Committee on Health, Sanitation and Nutrition conducted a Committee Hearing on April 26, 2023, 9:00 o'clock in the morning at the Gallery, Session Hall, 7/F Pasig Cityhall, to discuss the pertinent provisions of Proposed Resolution No.215, Series of 2023 entitled: "A RESOLUTION AUTHORIZING THE CITY GOVERNMENT OF PASIG THROUGH THE HONORABLE CITY MAYOR, VICTOR MA. REGIS N. SOTTO, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE DIABETES PHILIPPINES INC., PHILIPPINE ASSOCIATION OF DIABETES EDUCATORS AND ASSOCIATION OF DIABETES NURSE EDUCATORS OF THE PHILIPPINES, ASTRAZENECA PHARMACEUTICAL (PHILS.,) INC., KIDNEY TRANSPLANT ASSOCIATION OF THE PHILIPPINES, PHILIPPINE DIABETES SUPPORT AND TRANSPLANT PHILIPPINES, AND FOR OTHER PURPOSES".

The Committee Hearing was attended by Councilor Roderick Mario U. Gonzales, Councilor Syvel Asilo Gupilan, Councilor Simon Gerard R. Tantoco, Councilor Corazon M. Raymundo, Coun. Maria Luisa M. de Leon and Councilor Quin A. Cruz.

During the above-mentioned Committee Hearing the following were discussed:

1. Based on recent records, in Pasig alone, the incident of Chronic Kidney Disease increased in recent years. This is one of the reasons that the City established the Kidney Dialysis Center;
2. The cost of dialysis is too expensive and the amount provided by PhilHealth is not sufficient to treat patients with this condition;
3. The National Government incurred 12 billion pesos due to kidney dialysis;
4. Diabetes and Hypertension are the leading cause of chronic kidney disease and the aim of this project is to these diseases at an early stage to decrease the number of patients suffering from chronic kidney disease and eventually decrease the number of dialysis patients;
5. The project will give Pasiguenos free tests and screening of CKD with confirmatory testing. AstraZenica will provide free tests kits and machines to be used for said testing and screening;
6. The private partners will provide three testing machines which will be strategically positioned to barangays with the greatest number of potential patients with CKD;
7. The Councilors present proposed that this project be done also in public schools for early detection and prevention of CKD;
8. All the Councilors expressed their gratitude to AstraZeneca, the various diabetic societies and other private institutions involved in this project;
9. Councilor Syvel Asilo Gupilan and Councilor Simon Gerard R. Tantoco manifested their request to be Co-Sponsors of this Resolution in which the Chairperson gladly accepted.
