WHEREAS, in line with the foregoing, the City Government of Pasig and ASMPH will work collaboratively to implement the Community-Enhanced Internship Program (CEIP) by allowing ASMPH interns to participate in the programs, services, and activities of the Sta Lucia Health Center in Brgy. Sta Lucia and the Manggahan Super Health Center in Brgy. Manggahan, both of which are under the PCHD, and by establishing the specialty-based clinical services and public health programs and activities at Sta Lucia Health Center with rotations for interns at Manggahan Super Health Center. All of these are carried out in the context of the general rotating internship program of the ASMPH and its base hospital, The Medical City, with both Parties committing to achieve the learning outcomes of the CEIP through its implementation in the health center;

The Committee on Health, Sanitation and Nutrition and Committee on Education conducted a joint Committee Hearing on April 26, 2022, 10:00 o'clock in the morning at the Gallery, Session Hall, 7/F Pasig Cityhall, to discuss the pertinent provisions of Proposed Resolution No. 216, Series of 2023 entitled: "A RESOLUTION AUTHORIZING THE CITY GOVERNMENT OF PASIG THROUGH THE HONORABLE CITY MAYOR, VICTOR MA. REGIS N. SOTTO, TO ENTER INTO AND SIGN A MEMORANDUM OF UNDERSTANDING WITH THE ATENEO SCHOOL OF MEDICINE AND PUBLIC HEALTH, AND FOR OTHER PURPOSES".

The Committee Hearing was attended by Councilor Roderick Mario U. Gonzales, Councilor Syvel Asilo Gupilan, Councilor Simon Gerard R. Tantoco, Councilor Corazon M. Raymundo, Coun. Maria Luisa M. de Leon and Councilor Quin A. Cruz.

Dr. Rey Baquiran represented Ateneo School of Medicine to shed light regarding the Memorandum of Understanding to entered into by Ateneo and the City Government of Pasig.

During the above-mentioned Committee Hearing the following were discussed:

- 1. Dr. Baquiran informed the Council that their medical interns will be assigned in the health facilities located in Manggahan and Sta. Lucia, six interns in each Barangay;
- 2. The interns will not only assist in health centers of Manggahan and Sta. Lucia but will also assist in outreach medical services;
- 3. These interns will be supervised by Expert Doctors from Ateneo as well as Doctors assigned in our Health Centers;
- 4. The Ateneo interns will serve as augmentation to medical personnel assigned in those two barangays.

COMMITTEE RECOMMENDATION(S):

It has been the recommendation of the Committee on Health, Nutrition and the Committee on Education to adopt Proposed Resolution No. 216 series of 2023 and manifested that this resolution shall be passed for second and final reading in the next Regular Session.

The councilors present, as well as representatives from the City Health Office, expressed their gratitude to Ateneo School of Medicine for the project.


