NOW, THEREFORE, on a motion duly seconded, the Sangguniang Panlungsod resolves, as it hereby resolved, to authorize the Honorable City Mayor, Victor Ma. Regis N. Sotto, to grant financial assistance to the Pasig City Swimming Team in the amount of Thirty-Five Thousand Pesos (Php35,000.00) to help defray the cost of its participation in the upcoming COPA Golden Goggles Series (Leg 1 out of 4) on March 25 to 26, 2023 at Rizal Memorial Sports Complex, Vito Cruz, City of Manila.

RESOLVED, FURTHER, that the budgetary requirement to implement this Resolution shall be chargeable to the General Fund, as certified by the City Budget Office, and subject to existing COA rules and regulation.

COMMITTEE REPORT

The initial hearing was held on April 25, 2023 at the Session Hall, 7th Floor, Pasig City Hall, in the presence of majority of the members of the Committee on Appropriations, Ways and Means, together with representatives from the LYDO Office, City Budget Office, and Coach Carla of the Pasig City Swimming Team to discuss **Proposed Resolution No. 221-2023 entitled A Resolution Authorizing The Honorable City Mayor, Victor Ma. Regis N. Sotto To Grant Financial Assistance To Pasig City Swimming Team In The Amount Of Thirty-Five Thousand Pesos (PHP 35,000.00) To Help Defray The Cost Of Its Participation In The Upcoming Copa Golden Goggles Series (Leg 1 Out Of 4) On March 25 To 26, 2023 At Rizal Memorial Sports Complex, Vito Cruz, City Of Manila, And For Other Purposes.** which was referred to the committee during the Regular Session held April 11, 2023.


After a careful study and discussion, the following were finalized:

1. The Pasig City Swimming Team entered into the Copa Golden Goggles Series wherein the team was able to secure 3rd place overall, 2 most outstanding swimmers both male and female, 18 gold, 19 silver, and 20 bronze medals.
2. The financial assistance amounting to PHP 35,000.00 would cover costs of tournament and entry fees, food, and transportation.
3. The Committee recommends that this report be adopted, and the **Proposed Resolution No. 221-2023** be duly passed on its' second reading in the next regular session.
