simple homegrown Pasigueño of Barangay Caniogan and product of public schools such as Rizal Technological University (RTU), Rizal High School (High Honors) and recipient of the Pasig Scholarship Program for a total of 8 school years.

2. Out of the 6,070 who took the licensure examination for Mechanical Engineering examination where 3,774 passed (62.17%), Reynell finished as number one with a grade of 94.9 percent.
3. Providing inspiration to the young people of Pasig and the education programs of Pasig City, Ms. Ester Yamson of Pasig Scholarship Program, and Atty. Kathleen Villamin of the Education Unit, Office of the Mayor, cited that this extraordinary performance of Mr. Sanchez shall be taken as an important input in designing programs in the education sector.

Recommendations

1. For accuracy of the resolution, change the grade mentioned from 93.25 % to 94.9%.
2. It was suggested by Majority Floor Leader Volta delos Santos to present Mr. Sanchez with a plaque of recognition and with a privilege speech to be delivered by the Chair of the Committee on Education during the May 2 regular session of the 11th Sanggunian.




