A RESOLUTION APPROVING THE APPLICATIONS FOR MULTIMODAL TERMINAL SITES OF VARIOUS PUBLIC TRANSPORT PROVIDERS, AND FOR OTHER PURPOSES.

WHEREAS, Section 16 of Republic Act No. 7160, also known as the Local Government Code of 1991, vested authority to the local government units to exercise the powers expressly granted, those necessarily implied there from as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Further, the local government units are mandated to promote for the health, safety, comfort and convenience of all its inhabitants;

WHEREAS, Ordinance No. 23, Series of 2016, otherwise known as the Revised 2016 Traffic and Parking Management Code of Pasig City (the "Revised Traffic Code") provides for the traffic and parking rules and regulations for all transport vehicles operating within and traversing the territorial jurisdiction of the City of Pasig;

WHEREAS, Section 51-B, Paragraph D of the Revised Traffic Code provides that an application for terminal shall be approved upon the recommendation from the Traffic and Parking Management Office ("TPMO") and confirmation from the Business Permit and Licensing Office ("BPLO"). Further, the chairman of the Committee on Transportation of the Sangguniang Panlungsod will conduct a final evaluation of the said application and recommend the same for final approval of the Sangguniang Panlungsod;

WHEREAS, the following public transport providers have submitted their respective applications for multimodal terminal site for the approval of the City Government of Pasig, namely:



Committee Report

RE: **Proposed Resolution No. 236-2023:** A Resolution Approving the Application for Multimodal Terminal Sites of Various Public Transport Providers, and for Other Purposes.

Referred to the Committee on Transportation and Mobility on April 17, 2023

The Committee on Transportation and Mobility held its meeting on April 25, 2023, at around 3 o'clock in the afternoon to discuss the proposed Resolution No. 236-2023.

Present during the meeting were the Members of the Committee as follows: Councilors Quin Cruz, Mark Gil M. Delos Santos, Corazon M. Raymundo, and Raymund Francis S. Rustia. Invited resource persons present were: Atty. Isobelle Santocildes of Mayor's Office, Mr. Rodel L. Salvador of Tricycle Operations and Registration Office, Mr. Ronnie Fernandez and Mr. Jesse Abalora of Traffic and Parking Management Office, Mr. Ulysses Fabay of City Transport Development and various public transport providers namely: the Mamayan Sinagtala Transport Service Cooperative (MSTSC), Pasig Green City Transport and Multipurpose Cooperative (PGCTMC), and Township Transport Terminal, Inc. (T31), who are the proponents of the terminal applications.

The Traffic and Parking Management Office, after inspecting the terminal sites for approval and after Business Permit and Licensing Office's verification of the applicants' documents and records, have endorsed to this Committee for its final evaluation. The Committee confirmed with the UV groups the details of their qualifications and documentary requirements submitted to ensure that the applicants are fully informed of the matter they are applying for. The Committee emphasized that the approval may be revoked if the requirements they submitted were determined to be fraudulent.

After evaluating the applicants, the Committee found out that T31 offers multimodal transportation which includes city and provincial buses, Public Utility Vehicles, Public Utility Jeepneys, and they are also planning to include TODAs in the future. Considering this information, Atty. Santocildes suggested that the title be amended to "A Resolution Approving the Application for Multimodal Terminal Sites of Various Public Transport Providers, and for Other Purposes" to also cover the T31 being a multimodal public transport provider.
