A RESOLUTION AUTHORIZING THE CITY GOVERNMENT OF PASIG THROUGH THE HONORABLE CITY MAYOR, VICTOR MA. REGIS N. SOTTO, TO ENTER INTO AND SIGN A MULTI-YEAR LEASE CONTRACT FOR A PRIVATELY-OWNED REAL PROPERTY TO BE USED AS THE TEMPORARY PASIG CITY HALL, AND FOR OTHER PURPOSES.

WHEREAS, the current Pasig City Hall is an eight (8) storey building, composed of four (4) separate structures supported mainly by moment frames, approximately two thousand five hundred square meters (2,500 sqm) per floor, or a total floor area of twenty thousand (20,000) square meters;

WHEREAS, upon assumption of the administration of the Honorable City Mayor Victor Ma Regis N. Sotto on July 2019, certain cracks on the walls, uneven floor surfaces, and gaps between the buildings of the current City Hall were discovered:

WHEREAS, the administration immediately requested from the Engineering Department of the City Government for all the plans, blueprints, documents, and records in relation to all the buildings of the current City Hall;

WHEREAS, all the plans and records pertaining to the current city hall buildings were either lost or incomplete, proving impossible to produce a reliable assessment on the structural integrity of the buildings of the current City Hall;

WHEREAS, the City Government of Pasig engaged the services of SY^2 Associates, Inc., a structural engineering firm, as a consultant to determine whether the current City Hall is still structurally sound and safe to occupy;

WHEREAS, in SY<sup>2</sup> Associates, Inc.'s Final Structural Investigation Report of Pasig City Hall Building dated 15 February 2021, they concluded that the current city hall, composed of four (4) separate buildings, is no longer structurally sound and safe to occupy;

WHEREAS, based on the *findings* of SY^2 Associates, Inc., the current state of the current City Hall is no longer fit for use, and major works must be done immediately;

WHEREAS, the operations of the entire City Government of Pasig in the four (4) structurally unsound buildings must be relocated immediately for the safety of its occupants and visitors;

WHEREAS, in determining the best option on choosing the site of the temporary offices, the Implementing Guidelines for Lease of Privately-Owned Real Estate and Venue issued by the Government Procurement Policy Board ("GPPB") pursuant to Republic Act ("R.A.") No. 9184 should be observed;

WHEREAS, in determining the real property to lease, the GPPB mandates that a government agency must first explore the possibility of leasing from a public entity;

WHEREAS, there are no available real properties owned by the government in the City of Pasig, which matches the requirements to establish a Temporary City Hall; thus, the City shall explore leasing real properties from the private sector;

WHEREAS, in a study conducted by the Office of the City Administrator, it was determined that entering into a lease contract for a privately-owned real estate is more viable and beneficial to the City, as against purchasing land or leasing a government-owned real estate;

WHEREAS, on the basis of the foregoing, the City Government deemed it necessary to lease privately-owned real estate covering three (3) budget years (2022 to 2024);

WHEREAS, under Section 32 of R.A. No. 11936 or the General Appropriations Act for 2023 and Section 22 of the City Government of Pasig's Ordinance No. 31, Series of 2022, it is provided that in the case of recurring procurement projects such as rental of office space, the City may secure a Multi-Year Contracting Authority in the form of a Resolution from the Sangguniang Panlungsod;

NOW, THEREFORE, on motion duly seconded, subject to the provisions of R.A. No. 9184, its IRR, and relevant GPPB guidelines, the Sangguniang Panlungsod hereby resolves, as it hereby resolved, to authorize the City Government of Pasig through the Honorable City Mayor, Victor Ma. Regis N. Sotto, to enter into and sign a three (3) year Multi-Year Contract from 01 December 2023 until 31 December 2025 for the lease of a privately-owned real property to be used as the Temporary Pasig City Hall, as follows:

## Committee on Laws, Rules & Internal Government COMMITTEE REPORT

**Proposed Resolution No. 244-2023:** A Resolution Authorizing The City Government of Pasig Through The Honorable City Mayor, Victor Ma. Regis N. Sotto, To Enter Into And Sign A Multi- Year Contract For A Privately Owned Real Property To Be Used As The Temporary Pasig City Hall

Mr. Presiding Officer and Members of the 11th Sangguniang Panlungsod the Committee on Laws Rules and Internal Government respectfully presents & submits the Committee Report.

#### The Committee Respectfully Reports:

The committee chairperson manifested that the said proposed resolution -2023 is certified urgent by the Local Chief Executive.

It was manifested by City Administrator Atty. Jeronimo U. Manzanero that there is an urgency for this resolution to be passed by the City council as it will authorize the Honorable City Mayor Victor Ma. Regis N. Sotto to sign into a Multi-Year Contract for a private property that will be leased for the temporary housing of the City Hall Offices.

The granting of authority of the City Council to the City Mayor is needed as the said contract will last for 3 years where under the law, when an LGU will venture to a contract more than 1 year, approval from the council is needed.

The City Administrator narrated a brief history of the current City Hall structure whereas the said building is currently composed of 4 buildings combined together.

The first City hall building is the first 4 floors which was built during the 1960's and the second is the front part of the city hall and quadrangle built during the 1970's while the current 8 floor building of the city hall was erected last 1994 during the city's transition from municipality to a city. The last part of the city hall was built last 2017 which is the new wing of the city.

Upon the assumption of Mayor Sotto, the City engaged with the services of SY^2 Associates Inc. a structural engineering firm where as a consultant, they determined that the current City Hall is no longer structurally sound & safe to occupy.

As stated by the City Administrator, the results of the engineering consultancy and physical condition that is visible to the public, the City Government is looking for a possible private structure where the City can sign into contract for lease to house the various offices and services offered by the LGU.

Since there is a move to look for a temporary location for the City Hall, the LGU has been looking for a possible location where it is geographically strategic to the constituents where Atty. Manzanero identified that the area in C. Raymundo and Along C-5 is the best location to settle in.

In lieu of the temporary settlement of the City Hall, the committee was able to identify through the inquiry of Councilor Corazon Raymundo that the said temporary settlement will last for 3-4 years and if the City Council approves the said resolution, the said process of temporary settlement rental leasing will officially start on July 2024 since from July 2023-July 2024 is the period of transferring office equipments, supplies and other essential documents to the temporary settlement.

It was manifested by the City Administrator the city is eyeing to have one building for the said temporary settlement. That the said move to look for a temporary settlement of the City Hall will still go through the Bids & Awards Committee (BAC) for proper procurement and will be provided with the needed technical specification needed which includes that the actual floor area needed is only 10,000sqm to 12,000sqm since some of the city offices will remain in the current compound.

The committee was also able to identify that there is an allotment of Php. 80,000,000 for the first tranche of process of contract leasing with the private property and with the 2024 AIP in process, there will be additional budget to be requested in lieu of the process of leasing.

The committee moves to approve the said proposed resolution certified urgent by the City Mayor
