RESOLUTION AUTHORIZING THE CITY GOVERNMENT OF PASIG. THROUGH THE HONORABLE MAYOR VICTOR MA. REGIS N. SOTTO, TO GRANT MONTHLY FINANCIAL ASSISTANCE TO BARANGAY DELA PAZ IN THE AMOUNT OF FOUR THOUSAND PESOS (PHP4,000.00) TO SUBSIDIZE THE MONTHLY ELECTRICAL CONSUMPTION OF THE STREETLIGHTS LOCATED AT EMERALD VALLEY HOMES SUBDIVISION, BARANGAY DELA

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Section 17 (b)(1) of the Local Government Code of 1991, states that barangays shall exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities, which includes infrastructure facilities such as multi-purpose hall, multi-purpose pavement, plaza, sports center, and other similar facilities;

WHEREAS, Section 391 (g) of the same Code, empowers the Sangguniang Barangay to regulate the use of multi-purpose halls, multi- purpose pavements, grain or copra dryers, patios and other post-harvest facilities, Barangay waterworks, Barangay markets, parking areas or other similar facilities constructed with government funds within the jurisdiction of the Barangay and charge reasonable fees for the use thereof;

WHEREAS, given this mandate, Barangay Dela Paz, in its Barangay Ordinance No. 04, Series of 2021, as approved by the Sangguniang Panlungsod ng Pasig on September 2, 2021, regulates the use of government-owned facilities, multi-purpose buildings, open spaces and covered courts and other similar facilities within its jurisdiction;

WHEREAS, in Resolution No. 10, Series of 2021, the Barangay Dela Paz Council sought assistance from the City Government of Pasig to subsidize the monthly electrical consumption of government-owned buildings, and other similar facilities within the jurisdiction of Barangay Dela Paz, Pasig City, including the streetlights of Emerald Homes Subdivision;

#### **COMMITTEE REPORT**

The initial hearing was held on May 3, 2023 at the Session Hall, 7<sup>th</sup> Floor, Pasig City Hall, in the presence of majority of the members of the Committee on Appropriations, Ways and Means, Hon. Paul Roman C. Santiago, together with Kag. Andy Fernando from Barangay Dela Paz, Nelia N. Libiran, Teresita S. Cervantes, and Eliza L. Carandang from the Emerald Valley Homeowners Association to discuss Proposed Resolution No. 240-2023 entitled A Resolution Authorizing The City Government Of Pasig, Through The Honorable Mayor Victor Ma. Regis N. Sotto, To Grant Monthly Financial Assistance To Barangay Dela Paz In The Amount Of Four Thousand Pesos (PHP 4,000.00) To Subsidize The Monthly Electrical Consumption Of The Streetlights Located At Emerald Valley Homes Subdivision, Barangay Dela Paz, And For Other Purposes. which was referred to the committee during the Regular Session held April 24, 2023.

After a careful study and discussion, the following were finalized:

- 1. The representatives from Emerald Valley HoA raised that the actual bill amounts to around PHP 5,700. Committee chairperson explained that the city government would only subsidize 75% to 85% of the total, hence the amount of PHP 4,000 monthly.
- 2. For a better processing of the subsidy, the Committee chair explained that the subsidy would be given directly to Meralco.

The Committee recommends that this report be adopted, and the Proposed Resolution No. 240-2023 be duly passed on its' second reading in the next regular session.
