WHEREAS, the Rizal High School Alumni Association sought for financial assistance from the City Government of Pasig to defray the cost of conducting its sportsfest this year;

WHEREAS, as recognition to the numerous contributions of the graduates of Rizal High School to the development of Pasig City, the City Government deems it meritorious to grant financial assistance to the Rizal High School Alumni Association for the said purpose;

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod resolves, as it is hereby resolved, to authorize the Honorable City Mayor, Victor Ma. Regis N. Sotto, to grant financial assistance in the amount of One Hundred Thousand Pesos (Php 100,000.00) to the Rizal High School Alumni Association Sportsfest for the conduct of its sportsfest activity this calendar year 2023.

COMMITTEE REPORT

The initial hearing was held on May 3, 2023 at the Session Hall, 7th Floor, Pasig City Hall, in the presence of majority of the members of the Committee on Appropriations, Ways and Means, Hon. Paul Roman C. Santiago, together with Mr. Michael Sabino and Mr. Percival Lazaro, President and Sports Chairman of the Rizal High School Alumni Association respectively, to discuss Proposed Resolution No. 250-2023 entitled A Resolution Authorizing Honorable City Mayor, Victor Ma. Regis N. Sotto, To Grant Financial Assistance To Rizal High School Alumni Association, To Help Defray The Cost Of Their Sportsfest Activity This Calendar Year 2023, And For Other Purposes which was referred to the committee during the Regular Session held May 2, 2023.

After a careful study and discussion, the following were finalized:


- 1. The sportsfest of the RHS Alumni Assoc. would have 4 divisions of basketball, volleyball, and a one-day league for badminton and darts. There are 49 participating teams for basketball, with 4 divisions divided between decades of batches (80s, 90s, 2000s, & 2010s).
- 2. Councilors Raymundo and Delos Santos manifested their support to the RHS Alumni Association.
- 3. Councilor Raymundo proposed an amendment to the title and body of the resolution to include the amount of one hundred thousand pesos (PHP 100,000.00).
- 4. Mr. Sabino expresses gratitude to the city government for the assistance, and assures that the same would be used fairly and properly.

The Committee recommends that this report and its recommendations be adopted, and the Proposed Resolution No. 240-2023 be duly passed on its' second reading in the next regular session.
