A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, VICTOR MA. REGIS N. SOTTO TO GRANT FINANCIAL ASSISTANCE TO TWENTY-TWO (22) AFFECTED POOR AND UNDERPRIVILEGED SHARER FAMILIES OF ESGUERRA ST., BRGY. PINAGBUHATAN, PASIG CITY.

WHEREAS, Section 16 of the Republic Act No. 7160 otherwise known as the Local Government Code provides that, every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants.

WHEREAS, Section 28 of Republic Act No. 7279 otherwise known as the Urban Development and Housing Act and Section 14 of the Implementing Rules and Regulations of Republic Act 10752 or the Right of Way Act, provides that the City has the duty to provide housing relocation whether permanent or temporary to affected families or its monetary equivalent, among others;

WHEREAS, the twenty-two (22) poor and underprivileged sharer families are located at Esguerra St., Brgy. Pinagbuhatan, were victims of the fire incident last 11 April 2023;

WHEREAS, the said informal settler families have been duly validated by the Pasig Urban Settlements Office and the City Social Welfare and Development Office, as poor and underprivileged, as defined by the National Economic and Development Authority (NEDA);

WHEREAS, to ease to burden of the members of the community, and to aid them during this time of crisis, the City Government of Pasig deems it necessary to grant financial assistance to them in this time of need;

WHEREAS, the City Government shall provide financial assistance in the amount of Seven Thousand Pesos (₱7,000.00), for each of the twenty-two (22) affected sharer families listed below:




