A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR VICTOR MA. REGIS N. SOTTO, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE POSTAL CORPORATION FOR THE PRODUCTION, ISSUANCE, CIRCULATION, AND SALE OF COMMEMORATIVE STAMPS AND OTHER PHILATELIC PRODUCTS FOR THE 450TH ARAW NG PASIG, AND FOR OTHER PURPOSES.

**WHEREAS**, the City Government of Pasig is celebrating the 450th Araw ng Pasig on 02 July 2023;

**WHEREAS**, to mark this historical milestone, and in recognition of the fact that one of the first philatelic artists – Nemesio Dimanlig – was a Pasigueño, the City Government of Pasig has requested the Philippine Postal Corporation (PPC) to issue, circulate, and sell commemorative stamps and other philatelic products to promote the 450th Araw ng Pasig;

**WHEREAS**, the PPC, being the sole government entity mandated under the laws of the Philippines to produce, print, circulate, and sell commemorative stamps, has agreed to the request of the City Government;

**NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, BY THE CITY COUNCIL OF PASIG CITY, IN REGULAR SESSION DULY ASSEMBLED**, to authorize the City Government of Pasig, through the Honorable City Mayor, Victor Ma. Regis N. Sotto, to enter into and sign a Memorandum of Agreement with the Philippine Postal Corporation for the production, issuance, circulation, and sale of commemorative stamps for the 450th Araw ng Pasig;

**RESOLVED, FURTHERMORE**, that the copy of the Memorandum of Agreement shall form an integral part of this Resolution;

**RESOLVED, FINALLY**, that the Secretary of the Sangguniang Panlungsod furnish all concerned agencies/offices copies of this Resolution, as duly adopted/approved by the Sangguniang Panlungsod.

**Preliminaries**

The Committee on Cultural and Spiritual Affairs met on 10 May 2023 at the 7<sup>th</sup> Floor, Pasig City Hall, to discuss **Proposed Resolution No. 247-2023** entitled, **"A Resolution Authorizing the Honorable City Mayor, Victor Ma. Regis N. Sotto, to Enter into and Sign a Memorandum of Agreement with the Philippine Postal Corporation for the Production, Issuance, Circulation and Sale of Commemorative Stamps and Other Philatelic Products for the 450<sup>th</sup> Araw ng Pasig, and for other purposes."**

Resource persons present were Atty. Bernice Mendoza from the Office of the City Mayor and Mr. Val Tan of the Ugnayan ng Pasig.

**Summary of Discussion**

- Atty. Mendoza gave a brief background regarding the resolution. She stated that the event working committee agreed to apply for commemorative stamps to the Philippine Postal Corporation for the 450<sup>th</sup> Araw ng Pasig. Five (5) proposed designs were initially submitted wherein a maximum of three (3) designs can be chosen for the stamp. She also added that the quantity of the stamps is to be finalized and that they are hoping for the stamps to be released by July 2.
- The stamp designs were shown by Atty. Mendoza which include the following: Valentine Cruz, the Pasig City Museum, the Pariancillo Bridge, the Revolving Tower, and the Pasig Conception Cathedral Church.

- Councilor De Leon raised some suggestions on the designs of the stamps such as making the 450<sup>th</sup> logo more prominent, refraining from the use of black and white colors and blurry effect, and combining all significant figures as background of the 450<sup>th</sup> logo.

**Recommendation**

- To ensure that the commemorative stamps are made part of the celebration of the 450<sup>th</sup> Araw ng Pasig Celebration, the Committee on Cultural and Spiritual Affairs recommends that the Sanggunian adopt Proposed Resolution No. 247-2023, as attached, and authorize the Mayor to enter into the Memorandum of Agreement with the Philippine Postal Corporation for the Production, Issuance, Circulation and Sale of Commemorative Stamps and Other Philatelic Products for the 450<sup>th</sup> Araw ng Pasig.
