WHEREAS, Section 13 of the 1987 Constitution of the Philippines declares that the State recognizes the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, intellectual, and social wellbeing;

WHEREAS, Republic Act No. 11037, also known as the Masustansyang Pagkain Para sa Batang Pilipino Act, established a National Feeding Program to address under nutrition among Filipino children, which includes a Supplemental Feeding Program (SFP) for Day Care Children;

WHEREAS, the SFP covers undernourished children with ages three (3) to five (5) years, which shall include the provision of at least one (1) fortified meal to be served during snack or meal time of children enrolled in Child Development Center (CDCs), Supervised Neighborhood Play (SNPs) or community-based facilities for a period of not less than one hundred twenty (120) days in a year. The SNP also contributes to the early childhood care and development (ECCD) program of the government;

WHEREAS, the said Act mandates the Department of Education and the Department of Social Welfare and Development (DSWD), in consultation with other National Government Agencies (NGAs), Local Government Units (LGUs), Non-Government Organizations (NGOs), and development partners, to promulgate their respective rules and regulations for the efficient and effective implementation of the National Feeding Program;

WHEREAS, the efficient and effective implementation of the National Feeding Program shall sustain the gains of good nutrition achieved through the early childhood care and development services consistent with Republic Act No. 10410, otherwise known as the Early Years Act of 2013, and quality basic education services under Republic Act No. 10533, otherwise known as the Enhanced Basic Education Act of 2013;

WHEREAS, in the General Appropriation Act of 2022, the DSWD has set an 80% target outcome indicator for malnourished children in CDCs and SNPs with improved nutritional status;

WHEREAS, given the limitation in the purchasing power of most families due to extended effect of the COVID-19 pandemic and inflation of food commodities, SFP implementation shall assist in addressing the issue of hunger and food security among Filipino children and prevent regression of the current nutritional status of the beneficiaries;

WHEREAS, the DSWD has adopted alternative modes of implementation such as distribution of dry rations, nutripacks, nutribun with fresh milk, to address issues on the continuous delivery of services despite the shift of ECCD sessions from face-to-face to virtual learning;

WHEREAS, Sections 16 and 17 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates local government units to ensure and support, among other things, the promotion of health and safety, and preserve the comfort and convenience of their inhabitants; and provision of basic services and facilities such as programs and projects on child and youth welfare, family and community welfare;

WHEREAS, in the exercise of its mandate and in support of the goals of the SFP under the National Feeding Program, the City Government of Pasig deems it necessary to formalize its partnership with the Department of Social Welfare and Development to effectively and efficiently implement the SFP within the City of Pasig;

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod, resolves, as it hereby resolves, to authorize the City Mayor, Honorable Victor Ma. Regis N. Sotto, to enter into and sign a Memorandum of Understanding between the Department of Social Welfare and Development and the City Government of Pasig for the effective and efficient implementation of the Supplemental Feeding Program within the City of Pasig.

RESOLVED, FURTHER, that the copy of the said Memorandum of Understanding shall form an integral part of this Resolution.

RESOLVED, **FINALLY**, that the Secretary of the Sangguniang Panlungsod furnish all concerned agencies and/or offices with copies of this Resolution, as duly, adopted and approved by the Sangguniang Panlungsod.

Preliminaries

The Committee on Social Services and Solo Parent Affairs met on 10 May 2023 at the 7th Floor, Pasig City Hall, to discuss **Proposed Resolution No. 249-2023** entitled, "A **Resolution Authorizing the City Mayor Honorable Victor Ma. Regis N. Sotto To Enter Into And Sign A Memorandum Of Understanding Between The Department Of Social Welfare And Development And The City Government Of Pasig For The Implementation Of The Supplementary Feeding Program In The City Of Pasig, And For Other Purposes.**"

Resource persons present were Atty. Isobelle Santocildes from the Office of the City Mayor (OCM), Ms. Eileen Cruz from the City Health Office (CHO), and Ms. Sherryl A. Tutor and Ms. Frecelle C. Baraquel from the Office on Social Welfare and Development (OSWD).

Summary of Discussion

 Atty. Santocildes began the discussion by sharing that Pasig City intends to localize the the National Feeding Program of the government or the *Masustansyang Pagkain Para Sa Batang Pinoy Program* through the Memorandum of Understanding (MOU). It is important for the LGU to coordinate with the Department of Education (DepEd) and the Department of Social Welfare and Development (DSWD) for the meals provided in the Supplemental Feeding Program (SFP) given the conditions to be a beneficiary. Through the program, children are provided with their nutritional needs through meals, which contributes to their early childhood care and development.

- Ms. Baraquel of the OSWD stated that this project is on its 13th cycle since 2011, but was
 discontinued after 2019 due to the pandemic. The cycle usually starts during the opening
 of a school year and lasts for six (6) months.
- Since it was confirmed that the project is continuously conducted, Councilor De Leon suggested that an open-ended MOU may be considered to make its facilitation more efficient.
- On the effectiveness of the project, Ms. Cruz explained that the weight of the children are monitored monthly and the data is submitted to DSWD.

Recommendation

 To establish the local implementation of the "Masustansyang Pagkain Para Sa Batang Pinoy," the Committee on Social Services and Solo Parent Affairs recommends that the Sanggunian adopt Proposed Resolution No. 249-2023, as attached, and authorize the Mayor to enter into the Memorandum of Understanding with the Department of Social Welfare and Development (DSWD) for the implementation of the Supplementary Feeding Program within Pasig City.
