SOTTO TO GRANT FINANCIAL ASSISTANCE IN AMOUNT OF TWO MILLION FOUR HUNDRED FORTY-THREE THOUSAND FIVE HUNDRED PESOS (Php 2,443,500.00) TO THE UNITED PASIG CITY TRICYCLE DRIVER OPERATORS' ASSOCIATION FOR THE UPCOMING INTER-TODA SPORTSFEST, AND APPROPRIATING FUNDS THEREOF.

WHEREAS, the United Pasig City Tricycle Drivers Operators Association (UPCTODA), which was founded in 2021, is the only association in the City of Pasig that is duly registered and is composed of members of tricycles operators from Districts 1 and 2;

WHEREAS, UPCTODA sought for financial assistance from the City Government of Pasig to defray the cost of its participation in the upcoming Inter-TODA Sportsfest to be held on June 10, 2023 within Pasig City;

WHEREAS, the City Government of Pasig acknowledges the essential role of tricycles as a means of transportation and a key access point to public transport for every Pasigueño, and deems it meritorious to hereby grant financial assistance to the UPCTODA in the amount of Two Million Four Hundred Forty-Three Thousand Five Hundred Pesos (PhP2,443,500.00) to help defray the cost of its participation in the upcoming Inter-TODA Sportsfest;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, BY THE CITY COUNCIL OF PASIG, IN REGULAR SESSION DULY ASSEMBLED, to authorize the City Government of Pasig, through the Honorable Mayor Victor Ma Regis N. Sotto, to grant financial assistance to the United Pasig City Tricycle Drivers Operators Association (UPCTODA) in the amount of Two Million Four Hundred Forty-Three Thousand Five Hundred Pesos (Php 2,443,500.00) to help defray the cost of its participation in the upcoming Inter-TODA Sportsfest to be held on June 10, 2023 in Pasig City.

RESOLVED, FURTHER, that the budgetary requirement to implement the said Resolution shall be chargeable against any available funds in the City Treasurer subject to existing rules and regulations of the Commission on Audit;

RESOLVED, FURTHERMORE, that the UPCTODA is hereby directed to submit a liquidation report to the City Government of Pasig detailing its use of the funds given for the Inter-TODA Sportsfest within fifteen (15) days therefrom;

COMMITTEE REPORT

This report is to discuss Proposed Resolution No. 260-2023 entitled A Resolution Authorizing The Honorable City Mayor, Victor Ma. Regis N. Sotto To Grant Financial Assistance In The Amount Of Two Million Four Hundred Forty Three Thousand Five Hundred Pesos (Php 2,443,500.00) To The United Pasig City Tricycle Driver Operators Association (UPCTODA) For The Upcoming Inter-TODA Sportsfest And Appropriating Funds Thereof which was referred to the Committee on Appropriations, Ways and Means during the Special Session held May 12, 2023.

After a careful study and discussion, the following were finalized:

- The UPCTODA will be having its Inter-TODA Sportsfest wherein all TODAs of Pasig City will participate.
- The Sportsfest will comprise of 91 teams with 15 players per team. An estimated 1,300~ tricycle drivers and operators will be playing in the league and will conduct at most 170 games.
- The financial assistance would be used to cover the costs of the venue; sound systems; scoreboard and shot clocks; uniforms of coaches, players and organizers; practice and official balls; referees; food; and logistics, among others.
- 4. The venue and schedule of games are yet to be finalized, noting that the games would be held on time and days that would not negatively affect the tricycle drivers' earnings.

The Committee recommends that this report be adopted, and the Proposed Resolution No. 260-2023 be duly passed on its' second reading in the next regular session.
