A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, VICTOR MA. REGIS N. SOTTO, TO GRANT FINANCIAL ASSISTANCE IN THE AMOUNT OF ONE HUNDRED THOUSAND PESOS (PHP 100,000.00) TO THE METRO MANILA COUNCILORS' LEAGUE (MMCL) IN SUPPORT OF ITS GOLF TOURNAMENT, AND FOR OTHER PURPOSES.

WHEREAS, Section 36 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that a local government unit may, through its local chief executive and with the concurrence of the Sanggunian, provide assistance, financial or otherwise to non-governmental organizations for economic, socially-oriented, environmental, or cultural projects;

WHEREAS, the Metro Manila Councilors' League, with a membership of three hundred twelve (312) councilors from sixteen (16) cities and one (1) municipality in Metro Manila, is an official local government association accredited by the Department of Interior and Local Government;

WHEREAS, the Metro Manila Councilors' League, whose purpose is to be a leader in emerging trends in local administration and to improve the quality of life of the Filipino people through effective legislation, will be conducting a golf tournament to raise funds for its advocacies and programs;

WHEREAS, the City Government of Pasig acknowledges the need to support the Metro Manila Councilors' League and its fund-raising project and deems it meritorious to grant financial assistance to defray costs to be incurred in the said golf tournament;

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod ng Pasig resolves, as it hereby resolved, to authorize the Honorable City Mayor, Victor Ma. Regis N. Sotto, to grant financial assistance in the amount of One Hundred Thousand Pesos (Php 100,000.00) to the Metro Manila Councilors' League in support of its golf tournament.

RESOLVED, FINALLY, that the budgetary requirement to implement this Resolution shall be chargeable against any available funds in the City Treasury, subject to existing COA rules and regulations.

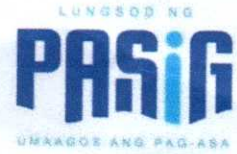


After a careful study and discussion, the following were finalized:
