Sotto, to grant financial assistance to the Pasig Karate-do/Japan Karatedo Organization in the amount of Thirty-Seven Thousand Four Hundred Twenty-Five Pesos (Php 37,425.00) to help defray the cost of its participation in the Southeast Asian Karate Federation Championship on March 13-19, 2023 at Rizal Memorial Coliseum, Manila.

RESOLVED, FURTHERMORE, that the budgetary requirement to implement this Resolution shall be chargeable to the Other Maintenance and Operating Expenses of the General Fund, as certified by the City Budget Office, and subject to existing COA rules and regulation;

The initial hearing was held on May 24, 2023 at the Session Hall, 7th Floor, Pasig City Hall, in the presence of majority of the members of the Committee on Appropriations, Ways and Means, with Michie Nazareth – Pasig Table Tennis, Mary Ann Toledo and Patricia Zamantha Baula – LYDO, to discuss Proposed Resolution No. 266-2023 entitled **A Resolution Authorizing The Honorable City Mayor, Victor Ma. Regis N. Sotto, To Grant Financial Assistance To Pasig Karate-Do/Japan Karatedo Organization In The Amount Of Thirty-Seven Thousand Four Hundred Twenty-Five Pesos (PHP 37,425.00) To Help Defray The Cost Of Its Participation In The Southeast Asian Karate Federation (SEAKF) Championship At Rizal Memorial Coliseum On March 13-19, 2023 And For Other Purposes** which was referred to the committee during the Regular Session held May 22, 2023.

After a careful study and discussion, the following were finalized:

1. The SEAKF Championship was part of the screening for players to participate in the 2023 SEA Games.
2. The financial assistance would defray the costs of entry fees, food allowance, and logistics.
