



The initial hearing was held on May 24, 2023 at the Session Hall, 7th Floor, Pasig City Hall, in the presence of majority of the members of the Committee on Appropriations, Ways and Means, with Ma. Lorna B. Ilaog, Eldin Sabuco, Christopher A. Romero – AKKAPP, Diwata Marie Reyes - PDAO to discuss Proposed Resolution No. 267-2023 entitled **A Resolution Authorizing The Honorable City Mayor, Victor Ma. Regis N. Sotto, To Grant Financial Assistance To Abot-Kamay Ng Mga Kapansanan Ang Pagunlad Ng Pasigueño Pasig Federation, Inc. In The Amount Of Ninety-Four Thousand Seven Hundred Fifty Pesos (PHP 94,750.00) To Defray The Cost Of Its Annual Celebration On May 4, 2023 At Privato Ortigas, Pasig City, And For Other Purposes** which was referred to the committee during the Regular Session held May 22, 2023.

After a careful study and discussion, the following were finalized:

1. The Abot-Kamay Ng Mga Kapansanan Ang Pagunlad Ng Pasigueño (AKKAPP) will be celebrating its 12th anniversary this 2023.
2. The celebration has yet to be done and the celebration was not held on May 4, 2023. In view of this, the committee recommends that the title and body of the resolution be amended to remove the date and venue of their annual celebration.

The Committee recommends that this report and its recommendations be adopted, and the Proposed Resolution No. 267-2023 be duly passed on its' second reading in the next regular or special session.


