A RESOLUTION AUTHORIZING THE CITY GOVERNMENT OF PASIG THROUGH THE HONORABLE CITY MAYOR, VICTOR MA. REGIS N. SOTTO, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH-TREATMENT AND REHABILITATION CENTER, BICUTAN FOR THE PROVISION OF ASSISTANCE TO FIRST TIME INDIGENT DRUG DEPENDENTS, AND FOR OTHER PURPOSES.

WHEREAS, Section 75 of Republic Act No. 1965, otherwise known as the Comprehensive Dangerous Drugs Act of 2002, provides that the management, operation, and maintenance of all government treatment and rehabilitation facilities were transferred to the Department of Health (DOH);

WHEREAS, local government units are required to appropriate funds in their annual budget to assist in or enhance the enforcement of the provisions found in the Comprehensive Dangerous Drugs Act of 2002, by giving priority to preventive or educational programs for the rehabilitation and treatment of drug dependency;

WHEREAS, Republic Act No.747, otherwise known as An Act to Regulate the Fees to be Charged Against Patients in Government Hospitals and Charity Clinics classifying Patients according to their Financial Condition, provides that the DOH may regulate and collect fees to be charged against patients in government and charity clinics proportionate to their financial capacities;

WHEREAS, patient classification by the DOH Administrative Order No. 51-A, Series of 2000 otherwise known as the Implementing Guidelines on the Classification of Patient and Availment of Medical Social Service in the Government Hospitals, implements a cost sharing scheme and mode of payment with the concerned local government unit;

WHEREAS, upon coordination of the DOH-Treatment and Rehabilitation Center Bicutan ("Center") and the Pasig City Anti-Drug Abuse Office, it has been agreed upon that the said Center shall provide assistance to first time indigent drug dependents as referred to by the City and that a monthly cost sharing rate per admitted first time drug dependent/patient in the amount of Twenty-Six Thousand Five Hundred (Php 26,500.00) for a fixed period of seven (7) months and Five Thousand For Hundred Pesos (Php 5,400.00) for three (3) months for an intensive aftercare program shall be shouldered by the City Government of Pasig;

WHEREAS, the City Government of Pasig and the DOH-Treatment and Rehabilitation Center Bicutan desires to formalize the said monthly cost sharing agreement in a Memorandum of Agreement;



Sotto, To Enter Into And Sign A Memorandum Of Agreement With The Department Of Health-Treatment And Rehabilitation Center Bicutan For The Provision Of Assistance To First Time Indigent Drug Dependents, And For Other Purposes.

Mr. Presiding Officer and Members of the 11th Sangguniang Panlungsod the Committee on Laws Rules and Internal Government respectfully presents & submits the Committee Report on Proposed Resolution 269-2023 conducted last May 25, 2023.

The Committee Respectfully Reports:

Ms. Zenaida Concepcion manifested that in the proposed resolution contains a Memorandum of Agreement (MOA) where it includes a clause about the renewal with the said facility where it was suggested that the renewal to be set for every 3 years instead of every year in order for the said payment to the facility not delayed.

Mr. Apolinario Landicho MPS, from the Treatment Facility states that there is a Php. 3,750 share of the LGU of Pasig to the said facility which was confirmed by Ms. Zenaida Concepcion.

The Committee Chairperson raised an inquiry about the laboratory procedures whereas it was answered by Mr. Landicho that the patients are not required to have their services in the treatment facility. This was supported by Dr. Amelito Javier that the City Government of Pasig can provide the majority of the laboratory services for free.

In the inquiry of Councilor Asilo about the minors who are affected of drugs, it was confirmed that there will be no minors included in the Memorandum of Agreement but the committee confirms that the said MOA can be revised and include the latest case 16 years old but subject to the approval of their executive committee since there is an existing memorandum from the Department of Social Welfare and Development (DSWD) that prohibits them from accepting minors in the facility. It was then mentioned by Committee Chairman delos Santos and Vice Chairperson Asilo that they are exploring possible partnerships with private institutions that can help rehabilitate the minors.

As Councilor Corazon Raymundo raised the question on why it was mentioned in the MOA that only first time offenders are the only one eligible for acceptance in the facility, Mr. Landicho confirmed that it is up to the LGU on whether or not they will send 2nd time offenders. There was an issue in terms of accepting 2nd time offenders in one of the partners of the City which is the reason why the city ADCOP opted not to include them. Instead, livelihood programs are given to the families of offenders.

Recommendation:

The committee would like to recommend to amend the "II. SCOPE OF SERVICES" of the said memorandum of agreement and remove section a, b and d as the said services can be offered free by the City Government of Pasig and will only retain section C.
