**WHEREAS**, the Philippine Vice Mayors' League is an official local government association accredited by the Department of Interior and Local Government;

**WHEREAS**, the Philippine Vice Mayors' League, whose purpose is to be a leader in emerging trends in local administration and to improve the quality of life of the Filipino people through effective legislation, will be conducting a golf tournament on June 29, 2023 at Wack-Wack Golf and Country Club, Mandaluyong City to raise funds for its advocacies and programs;

**WHEREAS**, the City Government of Pasig acknowledges the need to support the Philippine Vice Mayors' League and its fund-raising project and deems it meritorious to grant financial assistance to defray the costs to be incurred in the said golf tournament;

**NOW, THEREFORE**, on a motion duly seconded, the Sangguniang Panlungsod resolves, as it hereby resolved, to authorize the Honorable City Mayor, Victor Ma. Regis N. Sotto, to grant financial assistance in the amount of One Hundred Thousand Pesos (Php 100,000.00) to the Philippine Vice Mayors' League in support of its golf tournament on June 29, 2023 at Wack-Wack Golf and Country Club, Mandaluyong City.

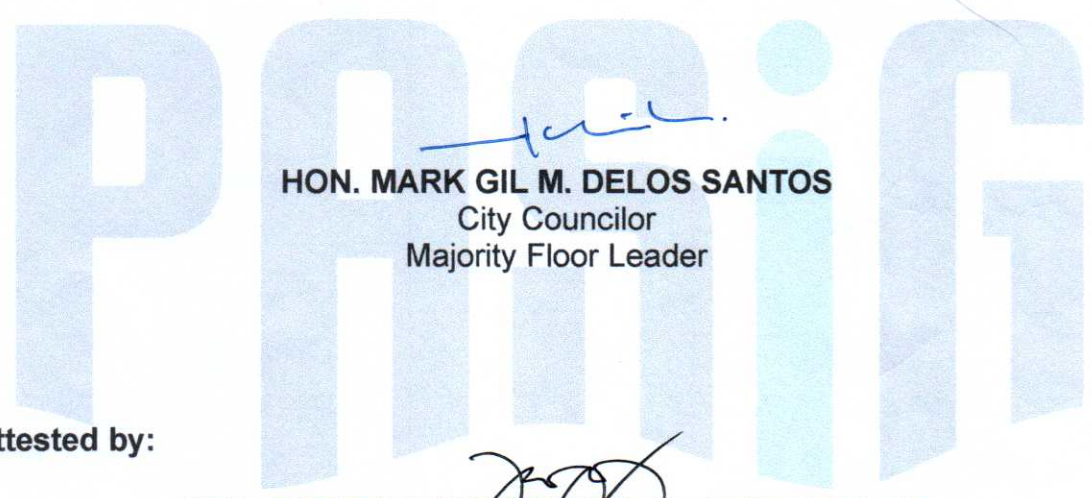

After a careful study and discussion, the following were finalized:


1. The Philippine Vice Mayor's League will hold a fundraiser golf tournament on June 29, 2023, at Wack-Wack Golf and Country Club.
