A RESOLUTION CONCURREING WITH AND CONFIRMING THE APPOINTMENT OF DR. GLICERIO MANINGAS AS THE 5TH PRESIDENT OF THE PAMANTASAN NG LUNGSOD NG PASIG (PLP), AND FOR OTHER PURPOSES.

WHEREAS, Section 6 of Republic Act No. 8262, otherwise known as the Higher Education Modernization Act of 1997, provide that the administration of the university or college shall be vested in the president of the university or college who shall be appointed by the Board of Regents, upon the recommendation of a duly constituted search committee and who shall have a term of four (4) years;

WHEREAS, the Commission on Higher Education constituted a Search Committee for President to start the search process for the next University President of the Pamantasan ng Lungsod ng Pasig ("PLP") as then PLP President, Dr. Amihan April M. Alcazar finished her ten (10) year service last July 2021. Thereafter, the Search Committee has submitted three (3) names for consideration and further deliberation of the PLP Board of Regents (PLP-BOR);

WHEREAS, the PLP-BOR met on May 22, 2023 to deliberate further on the submission of the Search Committee and unanimously selected then Officer-In-Charge Dr. Glicerio Maningas as the 5th President of the PLP. Thereafter, Dr. Maningas took his Oath of Office officiated by the Chairperson of the PLP-BOR, Honorable Mayor Victor Ma. Regis N. Sotto with the entire BOR as witnesses;

WHEREAS, the Sangguniang Panlungsod recognizes the urgent need to fill up the vacant position of the PLP President and fully concurs with the decision of the PLP-BOR;

NOW, THEREFORE, on a motion duly seconded, the Sangguniang Panlungsod resolves, as it is hereby resolved, to concur with and confirm the appointment of Dr. Dr. Glicerio Maningas as the 5th President of the Pamantasan ng Lungsod ng Pasig.

RESOLVED, FURTHERMORE, that the copy of the Oath of Office of Dr. Glicerio Maningas shall form an integral part of this Resolution;

RESOLVED, FINALLY, that the Secretary of the Sangguniang Panlungsod furnish all concerned agencies/offices copies of this Resolution, as duly adopted/approved by the Sangguniang Panlungsod.
