A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, VICTOR MA. REGIS N. SOTTO, TO GRANT FINANCIAL ASSISTANCE TO THE PASIG BADMINTON TEAM IN THE AMOUNT OF ONE HUNDRED FORTY-FOUR THOUSAND PESOS (PHP 144,000.00) TO HELP DEFRAY THE COST OF ITS TRAININGS AT THE UPPER DECK BADMINTON COURTS IN PASIG CITY, AND FOR OTHER PURPOSES.

WHEREAS, Section 11, Article II of the 1987 Constitution states that, the State recognizes the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, and social well-being. It shall inculcate in the youth patriotism and nationalism, and encourage their involvement in public and civic affairs;

WHEREAS, the Pasig City Badminton Team is asking for financial support from the City Government of Pasig for its training sessions to be held at the Upper Deck Badminton Courts in Pasig City. The administration of the Upper Deck gave the team a special rate of Six Thousand Pesos (PhP 6,000.00) for the use of five (5) badminton courts for two (2) hours. The team intends to use the said courts for the months of June and July 2023;

WHEREAS, the said trainings will be beneficial to the members of the team in their preparation for all possible tournaments they may compete in once classes start for School Year 2023-2024;

WHEREAS, providing support to the members of the Pasig City Badminton Team can significantly help in boosting their morale in future competitions, knowing that the City Government is behind them during their preparations.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod resolves, as it is hereby resolved, to authorize the Honorable City Mayor, Victor Ma Regis N. Sotto, to grant financial assistance to the Pasig Badminton Team in the amount of One Hundred Forty-Four Thousand Pesos (Php144,000.00) to help defray the cost of its training sessions at the Upper Deck Badminton Courts in Pasig City for the months of June and July 2023.

RESOLVED, FURTHERMORE, that the budgetary requirement to implement this Resolution shall be chargeable to the General Fund, as certified by the City Budget Office, and subject to existing COA rules and regulation.

COMMITTEE REPORT

The initial hearing was held on **June 7, 2023** at the Session Hall, 7th Floor, Pasig City Hall, in the presence of majority of the members of the Committee on Appropriations, Ways and Means, Hon. Paul Roman Santiago, Hon. Noel L. Agustin, Hon. Simon R. Tantoco, together with representatives from LYDO, Education Unit, City Budget Office and Coach Dominic John Aguirre – Pasig Badminton Team Coach to discuss **Proposed Resolution No. 274-2023** titled **A Resolution Authorizing The Honorable City Mayor, Victor Ma. Regis N. Sotto, To Grant Financial Assistance To The Pasig Badminton Team In The Amount Of One Hundred Forty-Four Thousand Pesos (Php144,000.00) To Defray The Cost Of Its Trainings At The Upper Deck Badminton Courts In Pasig City And For Other Purposes** which was referred to the Committee on Appropriations, Ways and Means during the Special Session held May 31, 2023.

After a careful study and discussion, the following were finalized:

1. According to Coach Aguirre, the financial assistance of PHP 144,000.00 would cover the venue costs for two (2) months of 2 hour trainings three (3) times a week. The team chose the Upper Deck badminton courts for its accessibility and a preferential discount granted for the team. The team previously trained at the Sto. Tomas Court, however the space has not been enough for the amount of players of the grassroots program
2. Committee Chairperson recommends that needed assistance is consolidated and processed early, to help the sports teams more efficiently. He also recommended a deeper development of measures to provide assistance or grants to Pasig City sports teams.

In view of the discussion, the Committee on Appropriations, Ways, and Means recommends that this committee report be adopted, and **Proposed Resolution No. 274-2023** titled **A Resolution Authorizing The Honorable City Mayor, Victor Ma. Regis N. Sotto, To Grant Financial Assistance To The Pasig Badminton Team In The Amount Of One Hundred Forty-Four Thousand Pesos (Php144,000.00) To Defray The Cost Of Its Trainings At The Upper Deck Badminton Courts In Pasig City And For Other Purposes** be passed on its 2nd reading in the next regular or special session.
