A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, VICTOR MA. REGIS N. SOTTO, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT BETWEEN THE CITY GOVERNMENT OF PASIG AND THE SAMAHANG BASKETBOL NG PILIPINAS FOR THE RENOVATION AND DESIGN OF A BASKETBALL COURT LOCATED AT KAPT. ATO ST., BRGY. STA. CRUZ, PASIG CITY, AND FOR OTHER PURPOSES.

WHEREAS, Section 13, Article II of the 1987 Constitution states that the State recognizes the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, and social well-being. It shall inculcate in the youth patriotism and nationalism, and encourage their involvement in public and civic affairs;

WHEREAS, Section 17, Article II of the 1987 Constitution states that the State shall also give priority to arts and sports to foster patriotism and nationalism, accelerate social progress, and promote total human liberation and development;

WHEREAS, Samahang Basketbol ng Pilipinas is the national sports association for basketball in the country, and is a member of the Federacion Internationale de Basketball (FIBA) of Mies, Switzerland;

WHEREAS, the City Government of Pasig and Samahang Basketbol ng Pilipinas, in their desire to promote the development of youth and to promote art within the community, have agreed to renovate a basketball court located at Kapt. Ato St., Brgy. Sta. Cruz, Pasig City, to showcase an artistic design on the court grounds and for the provision of new and improved basketball court paraphernalia;

NOW, THEREFORE, on a motion duly seconded, the Sangguniang Panlungsod resolves, as it hereby resolved, to authorize the Honorable City Mayor, Victor Ma Regis N. Sotto, to enter into and sign a Memorandum of Agreement between the City Government of Pasig and Samahang Basketbol ng Pilipinas, for the renovation and design of a basketball court located at Kapt. Ato St., Brgy. Sta. Cruz, Pasig City.

RESOLVED, FURTHERMORE, that the copies of the Memorandum of Agreement shall form an integral part of this Resolution;

RESOLVED, FINALLY, that the Secretary of the Sangguniang Panlungsod shall furnish all concerned agencies/offices copies of this Resolution, as duly adopted/approved by the Sangguniang Panlungsod.

COMMITTEE REPORT

The initial hearing was held on **June 7, 2023** at the Session Hall, 7th Floor, Pasig City Hall, in the presence of majority of the members of the Committee on Appropriations, Ways and Means, Hon. Paul Roman Santiago, Hon. Noel L. Agustin, Hon. Simon R. Tantoco, together with Barangay Sta. Cruz Captain Hon. Remedios Reyes, Barangay Sta. Cruz Kagawad Renz Andaya, Atty. Jayson Ababa and Atty Isobelle Santocildes from the Office of the City Mayor, and Atty. John Vincent Cernal from the Office of the General Services to discuss **Proposed Resolution No. 279-2023** titled **A Resolution Authorizing The Honorable City Mayor, Victor Ma. Regis N. Sotto, To Enter Into And Sign A Memorandum Of Agreement Between The City Government Of Pasig And The Samahang Basketball Ng Pilipinas, For The Renovation And Design Of Basketball Court Located At Kapt. Ato St. Brgy Sta. Cruz, Pasig City And For Other Purposes** which was referred to the Committee on Appropriations, Ways and Means during the Special Session held May 31, 2023.

After a careful study and discussion, the following were finalized:

1. A brief background on the measure was provided by Principal Author, Hon. Mark Gil M. Delos Santos. During discussions made with Samahang Basketball ng Pilipinas (SMB) in November, SMB proposed that they would conduct a basketball clinic in Pasig, which was done last June 3 and 4, 2023 in Barangays Kapasigan, Bagong Ilog, and San Miguel. Another proposal was made by SMB to choose one basketball court in Pasig to refurbish and redesign, hence the current resolution and memorandum of agreement for the Sta. Cruz Basketball Court, located at Kapitan Ato St., Brgy. Sta. Cruz, Pasig City. Hon. Delos Santos proposed an amendment to include Hon. Simon Gerard Tantoco as co-author of the resolution. The motion was duly seconded, and the committee recommends the amendment be adopted.
2. Atty. Ababa gave an overview of the provisions of the MoA and stated that the provisions therein are favorable to the City Government, and that they recognize the contribution of private entities in improving City facilities. He raises a concern on whether the period of three years would be amenable to the City Government. Committee Chairperson affirms that once the City Council authorizes the City Mayor to enter into the agreement, changes and review of the MoA can be done at the executive level.
3. Hon. Tantoco recommended that the City Government furnish copies of the resolution and MoA to concerned national agencies, for transparency. He also recommended that the MoA include a provision to allow the City Government to renovate or make changes to the Court within the 3-year period of the Agreement. Atty. Santocildes affirmed that they would add a clause providing that the MoA will not impede any public works should the need arise.
4. The side of the beneficiary, Sta. Cruz Barangay Captain Reyes explained their concern on the utilities of the Court. Committee Chairperson assures that the Barangay still has the right to collect payments for use of the court, the income which will then be appropriated for utilities.
5. All changes and designs that would be applied are subject to the approval of the City
