SOTTO, TO GRANT FINANCIAL ASSISTANCE TO THE PASIG CITY FENCING TEAM IN THE AMOUNT OF TWENTY-FIVE THOUSAND AND EIGHT HUNDRED PESOS (PHP 25,800.00) TO HELP DEFRAY THE COST OF ITS PARTICIPATION IN THE PHILIPPINE FENCING ASSOCIATION CADETS AND JUNIORS RANKING TOURNAMENT TO BE HELD AT THE PHILIPPINE SPORTS COMPLEX, PASIG CITY, PHILIPPINES ON JUNE 24-25, 2023, AND FOR OTHER PURPOSES.

It shall inculcate in the youth patriotism and nationalism, and encourage their involvement in public and civic affairs;

WHEREAS, the Pasig City Fencing Team is asking for financial support from the City Government of Pasig for its participation in the Philippine Fencing Association Cadets and Juniors Ranking Tournament to be held at the Philippine Sports Complex, Pasig City, Philippines on June 24-25, 2023;

WHEREAS, providing support to the team can significantly help in boosting the morale of its members who will face challenges during the competition knowing that the City Government is behind them;

NOW, THEREFORE, on a motion duly seconded, the Sangguniang Panlungsod resolves, as it hereby resolved, to authorize the City Mayor, Honorable Victor Ma Regis N. Sotto, to grant financial assistance to the Pasig City Fencing Team in the amount of Twenty-Five Thousand and Eight Hundred Pesos (Php25,800.00) to help defray the cost of its participation in the Philippine Fencing Association Cadets and Juniors Ranking Tournament to be held at the Philippine Sports Complex, Pasig City, Philippines on June 24-25, 2023.

RESOLVED, FURTHERMORE, that the budgetary requirement to implement this Resolution shall be chargeable to the Other Maintenance and Operating Expenses of the General Fund, as certified by the City Budget Office, and subject to existing COA rules and regulation;

RESOLVED, FINALLY, that the Secretary of the Sangguniang Panlungsod furnish all concerned agencies/offices copies of this Resolution, as duly adopted/approved by the Sangguniang Panlungsod.



COMMITTEE REPORT

The initial hearing was held on June 16, 2023 at the Session Hall, 7th Floor, Pasig City Hall, in the presence of majority of the members of the Committee on Appropriations, Ways and Means, together with Atty. Kathleen Villamin from the Education Unit, Coach Leanne Alonso, and Coach Noel Manaois – Fencing, to discuss **Proposed Resolution No. 301-2023** Entitled **A Resolution Authorizing The City Mayor, Honorable Victor Ma. Regis N. Sotto To Grant Financial Assistance To The Pasig City Fencing Team In The Amount Of Twenty-Five Thousand And Eight Hundred Pesos (PHP 25,800.00) To Help Defray The Cost Of Its Participation In The Philippine Fencing Association Cadets And Juniors Ranking Tournament To Be Held At The Philippine Sports Complex, Pasig City, Philippines, And For Other Purposes** which was referred to the committee during the Regular Session held June 13, 2023.

After a careful study and discussion, the following were finalized:

- 1. The financial assistance would cover the costs of entry fees and food of 26 athletes.
- 2. The fencing team is focusing on improving the performance of their athletes. 3 athletes from the fencing team were granted scholarships with the University of the East.
- 3. Committee chairperson recommended that the focus be on all sports, and not just popular and major sports.

The Committee recommends that this report be adopted, and the Proposed Resolution No. 301-2023 be duly passed on its' second reading in the next regular or special session.
