A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE VICTOR MA REGIS N. WHEREAS, providing support to the team can significantly help in boosting the morale of its members who will face challenges during the competition knowing that the City Government is behind them;

NOW, THEREFORE, on a motion duly seconded, the Sangguniang Panlungsod resolves, as it hereby resolved, to authorize the City Mayor, Honorable Victor Ma Regis N. Sotto, to grant financial assistance to the Pasig Fencing Team in the amount of Twenty-Six Thousand and Five Hundred Pesos (Php26,500.00) to help defray the cost of its participation in the Bladesmith Fencing Rookie Invitational to be held at the British School Manila Main Hall, Bonifacio Global City, Taguig City, Philippines on June 18, 2023.

RESOLVED, FURTHERMORE, that the budgetary requirement to implement this Resolution shall be chargeable to the Other Maintenance and Operating Expenses of the General Fund, as certified by the City Budget Office, and subject to existing COA rules and regulation;

RESOLVED, FINALLY, that the Secretary of the Sangguniang Panlungsod shall furnish all concerned agencies/offices copies of this Resolution, as duly adopted/approved by the Sangguniang Panlungsod.

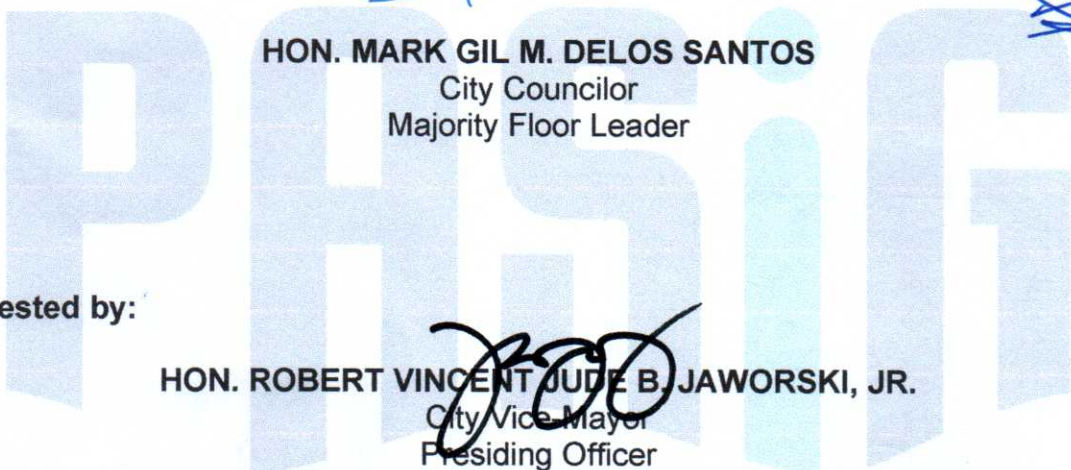

COMMITTEE REPORT

The initial hearing was held on June 16, 2023 at the Session Hall, 7th Floor, Pasig City Hall, in the presence of majority of the members of the Committee on Appropriations, Ways and Means, together with Atty. Kathleen Villamin from the Education Unit, Coach Leanne Alonso, and Coach Noel Manaois – Fencing, to discuss **Proposed Resolution No. 302-2023 Entitled A Resolution Authorizing The City Mayor, Honorable Victor Ma. Regis N. Sotto To Grant Financial Assistance To The Pasig Fencing Team In The Amount Of Twenty-Six Thousand And Five Hundred Pesos (PHP 26,500.00) To Help Defray The Cost Of Its Participation In The Bladesmith Fencing Rookie Invitational To Be Held At The British School Manila, Bonifacio Global City, Taguig City, Philippines on June 18, 2023 And For Other Purposes** which was referred to the committee during the Regular Session held June 13, 2023.

After a careful study and discussion, the following were finalized:

1. The amount of PHP 25,500.00 will be used for the competition fee and food allowance of 16 athletes and 4 coaches.
2. Atty. Kathleen Villamin explained the basis of the recommended amounts, some factors include available budget, number of participating athletes, and performance of teams. Atty. explained that they try to equitably allocate the funds to all teams.
3. Coach Leanne Alonso furthered that the unit also evaluates the competition itself.

The Committee recommends that this report be adopted, and the Proposed Resolution No. 302-2023 be duly passed on its' second reading in the next regular or special session.


