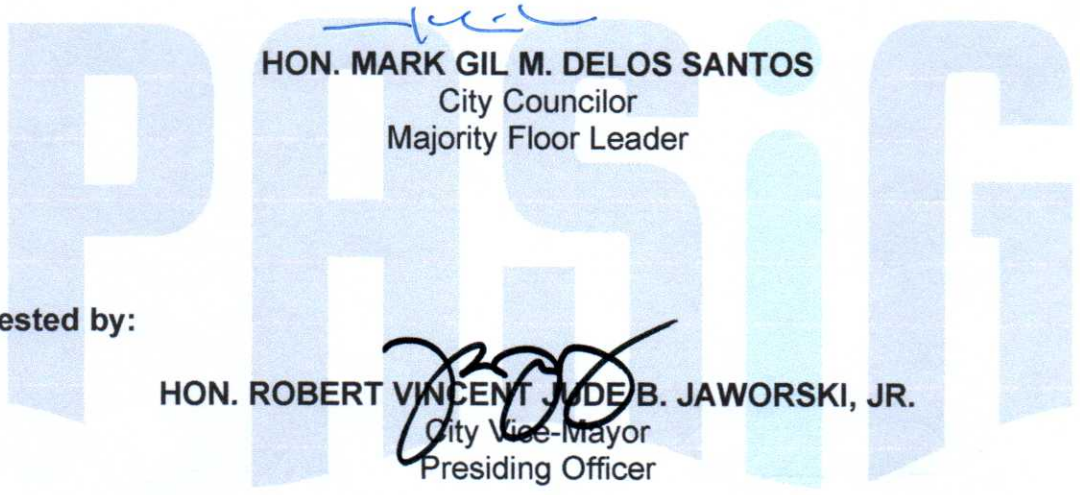

COMMITTEE REPORT

The initial hearing was held on June 16, 2023 at the Session Hall, 7th Floor, Pasig City Hall, in the presence of majority of the members of the Committee on Appropriations, Ways and Means, together with Atty. Kathleen Villamin from the Education Unit, Coach Leanne Alonso, and Coach Franco Camillo – Chess, to discuss **Proposed Resolution No. 303-2023** Entitled **A Resolution Authorizing The City Mayor, Honorable Victor Ma. Regis N. Sotto, To Grant Financial Assistance To The Pasig City Chess Team In The Amount Of One Hundred Forty Thousand And Two Hundred Fifty Pesos (PHP 140,250.00) To Help Defray The Cost Of Its Participation In The 21st ASEAN+ Age Group Chess Championship To Be Held On June 17 To 27, 2023 In Bangkok, Thailand, And For Other Purposes** which was referred to the committee during the Regular Session held June 13, 2023.

After a careful study and discussion, the following were finalized:

1. 5 athletes from the Pasig City Chess Team qualified for the 21st ASEAN+ Age Group Chess Championship.
2. Atty. Villamin raised that the education unit would like to reconsider and reallocate the financial assistance to a different competition, in consideration of the number of beneficiaries. Instead of the financial assistance being for the 21st ASEAN+ Age Group Chess Championship, it was requested that the financial assistance would be for the National Youth and School Chess Championship, held on June 2-10, 2023 in Dapitan, Zamboanga. Atty. Villamin also manifested for the amount to be increased from PHP 140,250.00 to PHP 141,750.00
3. Pursuant to this, the Committee recommends that the title and body of resolution be amended to read as A Resolution Authorizing The City Mayor, Honorable Victor Ma. Regis N. Sotto, To Grant Financial Assistance To The Pasig City Chess Team In The Amount Of One Hundred Forty One Thousand And Seven Hundred Fifty Pesos (PHP 141,750.00) To Help Defray The Cost Of Its Participation In The National Youth and School Chess Championship Held On June 2-10, 2023 In Dapitan, Zamboanga, And For Other Purposes.
4. The event held on June 2-10 yielded 2 silver medals for the standard category, 3 gold medals and 2 bronze medals for the rapid category, and 2 gold medals, 2 silver and 1 bronze for the blitz category.
5. Coach Alonso manifested that the chess team has really enhanced their program, noting that one of the grassroots athletes was named the Youngest Female National Master. Committee chairperson recommended that these athletes be given recognition during the 450th Araw ng Pasig Celebration.

The Committee recommends that this report be adopted, and the Proposed Resolution No. 303-2023 be duly passed on its' second reading in the next regular or special session.
