COMMITTEE REPORT

The initial hearing was held on June 16, 2023 at the Session Hall, 7th Floor, Pasig City Hall, in the presence of majority of the members of the Committee on Appropriations, Ways and Means, together with Atty. Kathleen Villamin from the Education Unit, Coach Leanne Alonso. and Coach Charlie Lachica - KARATEDO, to discuss Proposed Resolution No. 304-2023 Entitled A Resolution Authorizing The City Mayor, Honorable Victor Ma. Regis N. Sotto. To Grant Financial Assistance To The Pasig KARATE-Do In The Amount Of Eightyeight Thousand (PHP 88,000.00) To Help Defray The Cost Of Its Participation In The 2nd Shureido International Karate Cup To Be Held At Music Hall Of SM Mall Of Asia, Seaside Blvd., Pasay City, Philippines, And For Other Purposes which was referred to the committee during the Regular Session held June 13, 2023.

After a careful study and discussion, the following were finalized:

- 1. The financial assistance amounting to PHP 88,000.00 will be used to defray the costs of the entry fee and food for 24 athletes and 4 coaches.
- 2. Each athlete will participate in 2 categories, around 48 events will be participated in by the team.
- 3. The Pasig KARATE-Do has prepared athletes for the national level. One athlete from Pasig has already attained national athlete status, and represented the country in Thailand and Turkey last year. Some athletes are going through the qualifying process.

The Committee recommends that this report be adopted, and the Proposed Resolution No. 304-2023 be duly passed on its' second reading in the next regular or special session.
