**WHEREAS**, through this program payment of utility bills of the city will be done through electronic banking;

**WHEREAS**, there is a need to subscribe to the LANDBANK OF THE PHILIPPINES internet banking facility known as "weAccess" and to designate an authorized signatory to enroll and designate authorized user/s in the LANDBANK OF THE PHILIPPINES weAccess;

3. To amend/add/delete enrolled deposit account/s as source and/or destination accounts, access rights to the weAccess modules, authorization rules and/or any information on the original and succeeding enrollments.

**COMMITTEE REPORT**

The following report is to discuss **Proposed Resolution No. 197-2023** entitled **A Resolution Authorizing Honorable City Mayor, Victor Ma. Regis N. Sotto To Enter Into And Sign A Memorandum Of Agreement With Landbank Of The Philippines To Enroll In The Landbank Institutional Internet Banking "weAccess"** which was referred to the committee during the Regular Session held March 13, 2023.

After a careful study and discussion, the following were finalized:

1. The WeAccess program offers digital banking services which may be utilized by the City Government in payment of its utilities and other dues. The program will allow the City Government to make transactions and payments online. Subscription to the service is free of charge.
2. The City Government will utilize the WeAccess service in payment of its utilities. Moving forward, the city may also utilize the service for electronic payment of online biddings, payment of GSIS, MWSS, among others.
3. Authority will be given to the City Mayor to sign all documents necessary, and delegate authority to the City Accounting Office as the "Maker" and the City Treasury Office as the "Approver"

The Committee recommends that this report be adopted, and the Proposed Resolution No. 197-2023 be duly passed on its' second reading in the next regular or special session.
