A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE VICTOR MA. REGIS N. SOTTO, TO NEGOTIATE WITH THE LAND OWNER FOR THE ACQUISITION OF A PORTION OF LAND CONSISTING OF FIVE THOUSAND TWO HUNDRED SIXTY-SIX SQUARE METERS (5,266 SQ.M.) COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 011-2019001752 AND TAX DECLARATION NO. E-018-33403 REGISTERED UNDER THE NAME OF SPT LAND PROPERTIES INC., LOCATED IN ORTIGAS AVENUE, BARANGAY ROSARIO, PASIG CITY, TO BE UTILIZED AS RIGHT-OF-WAY OF THE ROSARIO SPORTS COMPLEX, AND FOR OTHER PURPOSES.

WHEREAS, a portion of land located in Barangay Rosario, Pasig City owned and registered in the name of SPT Land Properties Inc. is available as right-of-way for the Rosario Sports Complex;

WHEREAS, the portion of land contains an area of Five Thousand Two Hundred Sixty-Six Square Meters (5,266 sq.m.) covered by Transfer Certificate of Title No. 011-2019001752 and Tax Declaration No. E-018-33403 registered under the name of SPT Land Properties Inc. ("subject property");

WHEREAS, the subject property was determined and identified by the Land Management and Recovery Office to be suitable as right-of-way of the Rosario Sports Complex;

WHEREAS, it is necessary for the City Mayor, Honorable Victor Ma. Regis N. Sotto, to negotiate with SPT Land Properties Inc. for the acquisition of the subject property as right-of-way for the Rosario Sports Complex;

WHEREAS, the funds necessary in the negotiation for the acquisition of the subject property shall be taken from any available funds of the City Government of Pasig;

WHEREAS, the Sangguniang Panlungsod finds the same to be in order and necessary for the efficient delivery of basic services to the City's constituents;

NOW, THEREFORE, on a motion duly seconded, the Sangguniang Panlungsod resolves, as it hereby resolved, to authorize the City Mayor, Honorable Victor Ma. Regis N. Sotto, to negotiate with the land owner for the acquisition of a portion of land containing an area of Five Thousand Two Hundred Sixty-Six Square Meters (5,266 Sq.m.), covered by Transfer Certificate of Title No. 011-2019001752 and Tax Declaration E-018-33403 registered under the name of SPT Land Properties, Inc.;
