WHEREAS, a parcel of land located in Barangay San Miguel, Pasig City owned and registered in the name of Conchita Cruz is available to be taken by the City Government of Pasig as right-of-way for the benefit of the Lupang Pari Neighborhood Association;

WHEREAS, the parcel of land is covered by Transfer Certificate of Title No. 54037 with an area of One Hundred Square Meters (100 sq.m.) ("subject property");

WHEREAS, the subject property was determined by the Land Management and Recovery Office as a viable option to be utilized as right-of-way expansion in the Lupang Pari community;

WHEREAS, it is necessary for the City Mayor, Honorable Victor Ma. Regis N. Sotto, to negotiate with Conchita Cruz for the acquisition of the subject property to grant right-of-way to the Lupang Pari Neighborhood Association;

WHEREAS, the funds necessary in the negotiation for the acquisition of the subject property shall be taken from any available funds of the City Government of Pasig;

WHEREAS, the Sangguniang Panlungsod finds the same to be in order and necessary for the efficient delivery of basic services to the City's constituents;

NOW, THEREFORE, on a motion duly seconded, the Sangguniang Panlungsod resolves, as it hereby resolved, to authorize the City Mayor, Honorable Victor Ma. Regis N. Sotto, to negotiate with the land owner for the acquisition of a parcel of land consisting of One Hundred Square Meters (100 sq.m.), more or less, covered by Transfer Certificate of Title No. 54037, registered in the name of Conchita Cruz, located in Barangay San Miguel, Pasig City as rightof-way for the benefit of the Lupang Pari Neighborhood Association.

- Atty Malou also clarified during the discussion that there were no informal settlers, existing
 infrastructure, or any other thing that could have been considered an obstruction to the project as of
 the time of this hearing.
- 3. The Committee On Land Use agree to adopt all recommendations and amendments in this committee hearing of proposed resolution 287-2023, for 2nd reading this Monday, June 26, 2023 at the regular council session of the the 11th Sangguniang Panlungsod of Pasig.
