**WHEREAS**, Section 458 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, bestows upon the Sangguniang Panlungsod the power to enact ordinances, approve resolutions necessary for the efficient and effective administration of the city government;

In line with its mission, the PCEMPC is committed to providing excellent products and services for the benefit of its member-cooperators;

**WHEREAS**, the PCEMPC joins the City Government of Pasig in celebrating the 450<sup>th</sup> founding anniversary and is seeking financial assistance from the City Government of Pasig for its activities related to the 450<sup>th</sup> founding anniversary of the City;

**WHEREAS**, the City Government of Pasig supports the activities of the PCEMPC and deems it meritorious to grant the said request;

**NOW THEREFORE**, on a motion duly seconded, the Sangguniang Panlungsod resolves, as it hereby resolved, to authorize the Honorable City Mayor, Victor Ma. Regis N.
