**WHEREAS**, the City Government of Pasig has found sufficient cause to file an administrative case against Sheriff Benedict Boncato who implemented a Writ of Demolition dated 31 March 2023 issued by Branch 154 of the Pasig City Metropolitan Trial Court, and a Notice to Immediately Vacate dated 24 April 2023 causing the demolition of structures and removal of the personal belongings of the affected individuals;

**WHEREAS**, such acts were in violation of Republic Act No. 7292, otherwise known as the Urban Development and Housing Act of 1992, and Office of the Court Administrator Circular No. 328-2022 regarding the procedural guidelines in case of demolition and eviction and warrants the filing of an administrative case against Sheriff Boncato;

## **The Committee Respectfully Reports:**

### Discussion

1. The City Government of Pasig duly upheld the RA No. 7279 otherwise known as the Urban Development and Housing Act of 1992, and Court Administrator Circular No. 328-2022 that is the procedural guidelines in case of demolition and eviction through the filing of an administrative case by City Administrator, Atty. Jeronimo U. Manzanero against Sheriff Benedict Boncato for the violation of the laws thereof.
2. Sheriff Boncato through the issuance and implementation by Branch 154 of the Pasig City Metropolitan Trial Court of the Writ of Demolition dated 31 March 2023 did not follow proper procedure on his own discretion without the pertinent indispensable requirements such as the pre-demolition conference and the notices to be given to the local housing board or the city government.
3. The said indispensable requirements are of such importance especially to the Local Government Unit of Pasig as these requirements will also help them assist the displaced residents.
4. The administrative case to be filed is not within the jurisdiction of MTC, RTC, and Sheriffs, hence the filing before the Office of the Court Administrator.
5. An administrative case will initially be filed, if warranted, may be raised to a criminal case.
6. It was clarified that the authorization before the City Council of Pasig is necessary as they reach to different tribunals, courts, or office of the court administrators to file a case as representatives of the city.

### Recommendation

7. As the City Government of Pasig duly upholds the law, in this case particularly the RA no. 7279 and Court Administrator Circular No. 328-2022, and with the manifestation that what is right must be upheld and what is wrong must be corrected, the Committee recommends that the proposed resolution be approved at the next regular session.


