A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, VICTOR MA. REGIS N. SOTTO, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT BETWEEN THE SMART COMMUNICATIONS, INC., THROUGH ITS AUTHORIZED REPRESENTATIVE, JOSEMARIA MIGUEL O. FERNANDEZ, AND THE LOCAL GOVERNMENT OF PASIG CITY, FOR THE AFFILIATION IN THE WORLD HOOPS PENANG 3X3 CHALLENGER ON JUNE 10-11, 2023 AND IN THE CHAMPIONSHIP GAME IN MACAU ON JULY 8-9, 2023 IF THE TNT QUALIFIES FOR THE SAME, AND FOR OTHER PURPOSES.

**WHEREAS**, section 13, Article II of the 1987 Constitution states that, the State recognizes the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, and social well-being. It shall inculcate in the youth patriotism and nationalism, and encourage their involvement in public and civic affairs;

**WHEREAS**, section 17, Article II of the same states that, the State shall also give priority to arts and sports to foster patriotism and nationalism, accelerate social progress, and promote total human liberation and development;

**WHEREAS**, SMART owns TNT Triple Giga Team (TNT), a professional basketball team playing in the Philippine Basketball Association since 1990. SMART, through TNT, is one of the representatives of the Philippines in the World Hoops Penang 3x3 Challenger on June 10-11, 2023 and to the championship game in Macau on July 8-9, 2023 if TNT qualifies for the same;

**WHEREAS**, TNT needs a city-affiliate that they will represent in order to be able to qualify in the World Hoops Penang 3x3 Challenger;

**NOW, THEREFORE**, on a motion duly seconded, the Sangguniang Panlungsod resolves, as it hereby resolved, to authorize the Honorable City Mayor, Victor Ma. Regis N. Sotto, to enter into and sign a Memorandum of Agreement between the Smart Communications, Inc., through its authorized representative, Josemaria Miguel O. Fernandez, and the Local Government of Pasig City, for the affiliation in the World Hoops Penang 3x3 Challenger on June 10-11, 2023 and in the Championship Game in Macau on July 8-9, 2023 if the TNT qualifies for the same.

**RESOLVED, FURTHERMORE**, that the Memorandum of Agreement shall form an integral part of this Resolution;

**RESOLVED, FINALLY**, that the Secretary of the Sangguniang Panlungsod furnish all concerned agencies/offices copies of this Resolution, as duly adopted/approved by the Sangguniang Panlungsod.

**COMMITTEE REPORT**

The initial hearing was held on June 21, 2023 at the Session Hall, 7<sup>th</sup> Floor, Pasig City Hall, in the presence of majority of the members of the Committee on Appropriations, Ways and Means, , together with Atty. Jayson Ababa to discuss Proposed Resolution No. 306-2023 entitled **A Resolution Authorizing The Honorable City Mayor, Victor Ma. Regis N. Sotto, To Enter Into And Sign A Memorandum Of Agreement Between The Smart Communications Inc., Through Its Authorized Representative, Josemaria Miguel O. Fernandez, And The Local Government Of Pasig City, For The Affiliation In The World Hoops Penang 3X3 Challenger And In The Championship Game In Macau On July 8-9, 2023 If The TNT Qualifies For The Same, And For Other Purposes.** which was referred to the committee during the Regular Session held June 19, 2023.

After a careful study and discussion, the following were finalized:

1. The agreement was proposed by the Smart-TNT Triple Giga Team, as they are required to have a City-Affiliate to qualify for the World Hoops Penang 3x3 Challenger on June 10-11, 2023.
2. As City-Affiliate, TNT will be using the city logo in their jerseys and other branding. The City also has the right to partake in discussions regarding the event. This agreement comes at no cost to the City Government.
3. If the TNT Team successfully qualifies in the challenger, they will be able to continue to Macau on July 8-9 for the World Hoops Championships.

The Committee recommends that this report be adopted, and the Proposed Resolution No. 306-2023 be duly passed on its' second reading in the next regular or special session.






