Cruz, Sta. Rosa, Sto Tomas, Sumilang, Ugong, Dela Paz, Manggahan, Maybunga, Pinagbuhatan, Santolan, Sta Lucia, San Miguel and Rosario and Twenty-Seven (27) ambulances (patient transport vehicles) with blinker, siren and medical equipment to the following Barangays: Bambang, Bagong Ilog, Buting, Caniogan, Kalawaan, Kapasigan, Kapitolyo, Malinao, Oranbo, Palatiw, Pineda, Sagad, San Antonio, San Joaquin, San Jose, San Nicolas, Sta Cruz, Sta Rosa, Sto Tomas, Sumilang, Ugong, Manggahan, Maybunga, Pinagbuhatan, Santolan, Sta Lucia, and San Miguel;

**WHEREAS**, the Pasig City Risk Reduction and Management Council in its Resolution No. 4, Series of 2023 approved the said donation;

**WHEREAS**, a deed of donation will be given to the Barangay beneficiaries to transfer the ownership, encumbrances, and dues of the said vehicles to the abovementioned Barangays;




