

COMMITTEE REPORT

The following report is to discuss **Proposed Resolution No. 310-2023** entitled **A Resolution Authorizing The Honorable City Mayor, Victor Ma. Regis N. Sotto, To Grant A Monetary Award In The Amount Of Seven Thousand Pesos (Php 7,000) To Mr. John Romeo Z. Santillan In Recognition Of His Exemplary Performance In The Southeast Asian Games 2023 Artistic Gymnastic Competition - International Bracket, And For Other Purposes** which was referred to the Committee on Appropriations Ways and Means during the Regular Session held June 21, 2023.

After a careful study and discussion, the following were finalized:

1. Mr. John Romeo Z. Santillan competed in the Southeast Asian Games 2023 Artistic Gymnastic Competition at the ChroyChangvar International Convention Center, Phnom Penh, Cambodia on May 8, 2023 wherein he and his team won 2nd place and received silver medals.
2. Section 3.2 of Ordinance No. 52, Series of 2018 already provides for the monetary award to be granted without the need for legislation. Committee Chairperson proposed amendments to the title and body of the resolution to recognize the exemplary performance of Mr. Santillan.

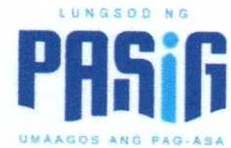
The Committee recommends that this report be adopted, and the Proposed Resolution No. 310-2023 be duly passed on its' second reading in the next regular or special session.
