SOTTO, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH HYUNDAI MOTOR PHILIPPINES, INC., IN GRANTING SCHOLARSHIPS TO RESIDENTS OF THE CITY OF PASIG AS PART OF HYUNDAI MOTOR PHILIPPINES, INC.'S CORPORATE SOCIAL RESPONSIBILITY, AND FOR OTHER PURPOSES RELEVANT THERETO.

**WHEREAS**, Hyundai Motor Philippines, Inc., a corporation duly organized and existing under the laws of the Republic of the Philippines, and engaged in the business of distribution of Hyundai brand of passenger cars and one (1) ton commercial vehicles in the Philippines, aims to provide education to work opportunities program for qualified underprivileged individuals as part of Hyundai Motor Philippines, Inc.'s Corporate Social Responsibility initiatives under its "Hyundai Accelerate" program;

**WHEREAS**, the City Government of Pasig is mandated by Sections 16 and 17 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, to exercise such powers and discharge such functions and responsibilities for the promotion of employment opportunities and support for education to its residents;

**WHEREAS**, Hyundai Motor Philippines, Inc., proposed to provide education support and opportunities for work assistance by sponsoring fifteen (15) qualified Pasig City residents for a one-(1) year Automotive Technology vocational program (school year 2023-2024) with Don Bosco Technical Institute of Makati and, thereafter, to engage in relevant automotive related trainings within the Hyundai Dealer Network, to develop technical knowledge enhancements and work opportunities in the industry;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF PASIG CITY, IN REGULAR SESSION DULY ASSEMBLED**, to authorize the City Mayor, Honorable Victor Ma. Regis N. Sotto, to enter into and sign a Memorandum of Agreement with Hyundai Motor Philippines, Inc., for the implementation of its Corporate Social Responsibility initiatives for the benefit of Pasig City Residents.

**RESOLVED, FURTHER**, that the City Mayor be authorized to accept the CSR initiatives of Hyundai Motor Philippines, Inc., of sponsoring the relevant tuition fee or school fee of fifteen (15) qualified Pasig City residents for a one-(1) year Automotive Technology vocational program with Don Bosco Technical Institute of Makati;

#### Introduction

As per request of Chairperson of the meeting, Mr. Paul Herrera gave a brief description of the project. That as part of the Hyundai Motors Corporate Social Responsibility, they are granting scholarships to fifteen (15) senior high school graduates to complete a Diploma on Automotive Technology at the Don Bosco Technical Institute, Makati including an 8-months in school and 4 months deployment to a Hyundai dealers' site with the possibility of being given an allowance during the practicum. Being hired by the dealer is also a possibility.

On behalf of the city Government, the Chair acknowledged the generosity of Hyundai Motors and that the project goes well with another project of Pasig City called Opportunities 2.0 which enhances learning which directly collaborates with industries for work opportunity.

**During the discussion proper, the following were raised/added/resolved:**

**1. On the resolution itself,**

- Mr. Herrera clarified that instead of 10 scholarships, this has been increased to 15.
- For the eligibility of beneficiaries, instead of the previous senior high school graduates of last two academic years (2021-22 and 2022-23), beneficiaries shall be of ages 18-30 to widen the coverage of beneficiaries.
- The Local Government of Pasig will have the Education Unit as its implementing arm of the project.

**2. On the draft Memorandum of Agreement, discussed were the following:**

- Timetable: It was informed that classes for the grant begins on first week of August, therefore the screening and identifying of recipients should be done with urgency. This is the responsibility of the LGU.
- Signing of MOA should happen in July with Mayor Sotto and Hyundai President Dong Wook Lee as signatories. The Office of the Mayor thru the Education Unit will be in charge.
- The MOA shall be between Pasig City and Hyundai Motors Philippines. To show the Don Bosco part, a separate MOA has been penned between Hyundai and Don Bosco. There should be a cross reference in the Hyundai-Pasig MOA of the Don Bosco component in the project.
- The finalization of the MOA shall be the responsibility of the Office of the Mayor (Atty Villamin in particular)
- On improving the success of the project, a monitoring scheme was discussed with the following components:
  - o Quarterly Conference of Students with Parents at Don Bosco with Hyundai officers and representatives of LGU as observers (Coun. Raymundo and Atty. Villamin)
  - o Reports of student progress from Don Bosco to be sent to Hyundai and in turn, Hyundai to Pasig City Government.



### 3. The Look Ahead

- a. Mr. Herrera shared that this proposed measure is only Phase 1 of their CSR. They need to monitor the results of this phase so they can configure the Phase 2 better. This was seen as a positive sign for continuing or expanding the Pasig City present engagement through this resolution.
