WHEREAS, there are (12) informal settler families located at 143 Dr. Sixto Antonio Ave., Brgy. Rosario, Pasig City who are subject of judicial proceedings, wherein the court ordered, with finality, that they should vacate the subject property;

WHEREAS, the said informal settler families, who are named below, have been duly validated by the City Social Welfare and Development Office as underprivileged and homeless, as defined in Republic Act 7279 or the Urban Development and Housing Act of 1992 (UDHA):

WHEREAS, in coordination with the Pasig Urban Settlements Office ("PUSO"), these informal settler families are invoking the provisions of the UDHA and are requesting assistance from the local government;

WHEREAS, to ease to burden of the other members of the community, and to aid them during this time of pandemic, the City Government of Pasig deems it necessary to grant financial assistance to them based on the provisions of the UDHA;

NOW, THEREFORE ON SESSION DULY ASSEMBLED, THE SANGGUNIANG PANLUNGSOD, RESOLVES, AS IT IS HEREBY RESOLVED, to authorize the Honorable City Mayor, Victor Ma. Regis N. Referred to the Committee on Human Settlements and Urban Development on June 19, 2023

The Committee on Human Settlements and Urban Development held its meeting on June 29, 2023 at around 1 o' clock in the afternoon to discuss the proposed Resolutions.

Present during the meeting were the Members of the Committee as follows: Councilors Quin Cruz and Mark Gil M. Delos Santos. Also present were Councilors Corazon M. Raymundo and Roderick Mario U. Gonzales.

Invited resource persons present were: Ms. Marites Dayap of City Social Welfare Department (CSWD) and Mr. Manny Manato of Pasig Urban Settlements Office. Also present were the displaced families of Brgys. Rosario and Pinagbuhatan.

The CSWD has validated a total of 4 structures owners who will be granted Php34,200.00 by virtue of Republic Act No. 7279 and 8 sharers who are entitled to a grant of Php5,000.00. As to the displaced family of Brgy. Pinagbuhatan, 1 structure owner will be granted Php34,200.

The displaced families from Brgy. Rosario were evicted without a Pre-Demolition Conference ("PDC"). Due to this, the sheriff who executed the Order of eviction without proper procedure will be facing an administrative case which will be filed by the City Government. As to the family from Brgy. Pinagbuhatan, there is also no PDC conducted yet; hence, no eviction shall be executed yet.

The Committee upholds the rule of law and due process and recognizes the decision of the court but also sympathizes with the families who lost their homes for how many years. The Committee will stand to ensure that proper procedures is observed in this kind of matter where families are affected.
