WHEREAS, there is an informal settler family located at 298 Esguerra St. cor. Villa Monica Compound, Brgy. Pinagbuhatan, Pasig City who are subject of judicial proceedings, wherein the court ordered, with finality, that they should vacate the subject property;

WHEREAS, the said informal settler family, namely the family of Mr. Edemar M. Cardosa, has been duly validated by the City Social Welfare and Development Office as underprivileged and homeless, as defined in Republic Act No. 7279 or the Urban Development and Housing Act of 1992 (UDHA);

WHEREAS, in coordination with the Pasig Urban Settlements Office, the informal settler family is invoking the provisions of the UDHA and is requesting assistance from the local government;

WHEREAS, to ease to burden of the other members of the community, and to aid them during this time of pandemic, the City Government of Pasig deems it necessary to grant financial assistance to them based on the provisions of the UDHA in the amount equivalent to the prevailing minimum wage times sixty (60) days;

NOW, THEREFORE, ON SESSION DULY ASSEMBLED, THE SANGGUNIANG PANLUNGSOD, RESOLVES, AS IT IS HEREBY RESOLVED, to authorize the Honorable City Mayor Victor Ma. Regis N. Sotto, to grant financial assistance to one (1) informal settler family, namely the family of Mr. Edemar M. Cardosa, in the amount of Thirty-Four Thousand Two Hundred Pesos (PhP34,200.00), due to their displacement and in compliance with the provisions of the UDHA;

RESOLVED, FINALLY, that the budgetary requirement to implement this Resolution shall be chargeable against any available funds in the City Treasury, subject to existing COA rules and regulations.
