WHEREAS, pursuant to Section 12 (6) (3.2) of Republic Act No. 10121, otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010, the Disaster Risk Reduction and Management Plans are formulated covering 5% of the LDRRMF;

WHEREAS, pursuant to Section 21, paragraph 3 of R.A. 10121 and Rule 18 of its Implementing Rules and Regulations, as well as No. 6.5 of the Joint Memorandum Circular No. 2013-1 series of 2013 of the National Disaster Risk Reduction and Management Council, Department of Budget and Management, and Department of the Interior and Local Government as to the allocation and utilization of the LDRRMF, the unexpended amount under Special Trust Fund, Php 29,919,194.92 from CY 2018, Php 72,871,077.92 from CY 2019, Php 37,946,743.76 from CY 2020, Php 188,876,271 from CY 2021 and Php 248,446,654.65 from CY 2022 and DRRMF Continuing Appropriation amounting to Php 64,462,188.01 from CY 2022 are reprogrammed and incorporated upon recommendation of the Disaster Risk Reduction and Management Officer to a Supplemental Investment Plan and Local Disaster Risk Reduction and Management Fund Investment Plan for CY 2023 of the City of Pasig;

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod resolves, as it is hereby resolved, to adopt the Pasig City Disaster Risk Reduction and Management Council's, Resolution No. 3, Series Of 2023, entitled "A Resolution Approving the Pasig City Supplemental Investment Plan (SIP) and Pasig City Local Disaster Risk Reduction And Management Fund Investment Plan (LDRRMFIP) of the Local Disaster Risk Reduction and Management Fund (LDRRMF) Unexpended Balances For Special Trust Fund Cy 2018, 2019, 2020, 2021 And 2022 and DRRMF Continuing Appropriation For 2023".

COMMITTEE REPORT

Committee on Appropriations, Ways and Means & Committee on Infrastructure

The initial hearing was held on July 10, 2023 at the Session Hall, 7th Floor, Pasig City Hall, in the presence of majority of the members of the Committee on Appropriations, Ways, and Means, jointly with the Committee on Infrastructure, with Mr. Bryant Meryll Ruiz Q. Wong from the to discuss Proposed Resolution No. 324 titled A Resolution Adopting The Pasig City Disaster Risk Reduction And Management Council, Resolution No. 3, Entitled "A Resolution Approving The Pasig City Supplemental Investment Plan (SIP) And Pasig City Local Risk Reduction And Management Fund Investment Plan (LDRRMFIP) Of The Local Risk Reduction And Management Fund (LDRRMF) Unexpected Balances for Special Trust Fund CY 2018, 2019, 2020, 2021 And 2022 And DRRMF Continuing Appropriation For CY 2023" And For Other Purposes which was referred to the Committee during the Regular Session held July 10, 2023.

After a careful study and discussion, the following were finalized:

1. Unexpended amount from the Special Trust Funds for the years 2018, 2019, 2020, 2021, and 2022, and the DRRMF Continuing Appropriations from CY 2022 are as follows:

The amounts herein were recommended for inclusion in the Supplemental Investment Plan and Local Disaster Risk Reduction Management Fund Investment Plan for CY 2023.

- 2. Appropriations made for the Disaster Risk Reduction and Management Program include Procurement of Advanced Life Support Ambulance; Anti-Drone System; Fire-Rescue Vehicle & Equipment; Emergency Go Bags for constituents; consultancy services; upgrading of PCDRRMO EC3 Information System; repair of Command Center system & equipment; purchase of supplies and equipment for emergency management.
- 3. An inquiry was posed on the content of the Go Bags, Mr. Wong explained that it would contain flashlight, whistle, emergency blanket, emergency contact numbers. Committee members commended the plans, and requested that the items for distribution be of good quality.

In view of the discussion, the Committee on Appropriations, Ways, and Means recommends that this report be adopted, and Proposed Proposed Resolution No. 324-2023 be passed on its second reading in the next regular or special session.
