WHEREAS, the recently enacted Republic Act. No. 11697 or Electric Vehicle Industry Development Act, aims to provide an enabling environment for the development of electric vehicles as an attractive and feasible mode of transportation to reduce the country's dependence on fossil fuels;

WHEREAS, the City Government of Pasig, through Resolution No. 149, Series of 2019, expressed its willingness to support the Project and will enter into a Memorandum of Agreement with DOTr;

WHEREAS, UNDP-LCT, through its partners at CHRG EV Technologies, Inc. shall conduct a feasibility study for the design and installation of Electric Vehicle Charging Stations (EVCS) at two (2) locations in the City of Pasig – Pasig City Mega Parking II and Pasig Kabuhayan Center, East Bank Road, Barangay Sta. Lucia;

WHEREAS, the Department of Public Works and Highways is the current owner of the lot wherein the Pasig Kabuhayan Center is currently located and has agreed to authorize the use of the lot for the purpose of the Project;

WHEREAS, in Executive Order No. 63, Series of 2021, the City Government of Pasig established the Pasig E-Mobility Steering Committee to mainstream sustainable electric mobility solutions to protect public health from harmful transport emissions;

WHEREAS, the Parties recognize the value of working together to improve air quality as well as promote environmental sustainability in the City of Pasig and intends to formalize their commitment through a Memorandum of Agreement;

NOW, THEREFORE, on a motion duly seconded, the Sangguniang Panlungsod resolves, as it is hereby resolved, to authorize the Honorable City Mayor, Victor Ma Regis N. Sotto, to enter into and sign a Tripartite Agreement with the Department of Transportation and the Department of Public Works and Highways for the conduct of a feasibility study for the design and installation of Electric Vehicle Charging Stations in the City of Pasig.

RESOLVED FURTHERMORE, that copies of the Memorandum of Agreement shall form an integral part of this Resolution;

RESOLVED, FINALLY, that the Secretary of the Sangguniang Panlungsod shall furnish all concerned agencies/offices copies of this Resolution, as duly adopted by the Sangguniang Panlungsod.

The DOTr has partnered with the UNDP to initiate the execution of the Promotion of Low Carbon Urban Transport System in the Philippines (LCT) Project, funded under the Global Environmental Facility (GEF), with the aim of promoting sustainable transportation system in the Philippines by creating enabling environments for motorized and non-motorized low carbon transport options.

The objective of the partnership of the DOTr-UNDP LCT Project necessitates efforts and collaboration between the national government agency and local government units and mainstream it in the local aspect. The DOTr and UNDP have selected Pasig City as a pilot site for the LCT Project, and the City Government of Pasig has expressed its willingness to support the same especially as it is in the process of preparing its Transport Development Plan.

Some of the projects that was initiated in connection with the promotion of low carbon transport system are the following:

1. People's Street in Ortigas;
2. Bike-to-School Program, where students, teachers and staff biked their way to school;
3. Establishment of e-vehicles charging stations particularly in Brgy. Sta. Lucia and Mega Parking II;
4. Pasig TODA Consultation with Pasig Transport Cooperative Program Technical Working Group to help promote e-vehicles and cooperatives;
5. Workshops on Low Carbon Streets with the Barangay Personnel and Pasig LGU offices; and
6. Workshop on Gender Equality and Social Inclusion for the Transport Cooperatives with the help of Cooperative Development Office.

UNDP, through its partners at CHRG EV Technologies, Inc. shall conduct a feasibility study for the design and installation of Electric Vehicle Charging Stations (EVCS) at two (2) locations in the City of Pasig. DOTr will also donate various equipment to facilitate the LCT Project through a Deed of Donation.

The following points were also raised and noted, and were duly adopted by the Committee as recommendations:

1. That the Pasig City Executive Order No. 63 Series of 2021 appointing members to the Pasig E-Mobility Steering Committee be updated and recalibrated to align according to the needs of the LCT Project and future e-mobility projects.
2. That the Comprehensive Roadmap for Electric Vehicle Industry (CREVI), which is a national development plan for the electric vehicle (EV) industry with an annual work plan to accelerate the development, commercialization and utilization of EVs in the country, be included in the updating of the Comprehensive Land and Water Use Plan of the City;
3. That proper permits issued by the national government agencies and local government units, such as the Environmental Compliance Certificate by the Department of Environment and Natural Resources, Product Certificate of Quality and/or Safety by the Department of Trade and Industry, Fire Safety Inspection Certificate by the Bureau of Fire Protection, and Business Permit by the Pasig BPLD, Locational/Zoning Clearance by the City Planning, be secured to ensure that the EVCS is in compliance with the existing policy.
4. The inclusion of the Chairperson of Committee of Transportation and Mobility, Coun. Quin A. Cruz, as one of the sponsors of Proposed Resolution No. 319-2023.

Furthermore, the Committee recommends the inclusion of the Proposed Resolution to the Regular Session of the 11th Sanggunian of Pasig City for approval.
