WHEREAS, Section 458 (1) (xi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that local government units may grant allowances and other benefits to national government officials stationed in or assigned in the City;

WHEREAS, as an incentive to the Action Officer of MMDA stationed in the City of Pasig, there is a need to provide them with monthly allowance;

NOW, THEREFORE, on motion duly seconded, the City Council resolves as it is hereby resolved, to authorize the Honorable City Mayor Victor Ma. Regis N. Sotto to grant monthly allowance of ten thousand pesos (PHP 10,000.00) to the Metro Manila Development Authority (MMDA) Action Officer assigned in the City of Pasig.

RESOLVED, FURTHER, that the budgetary requirements to implement this resolution shall be chargeable against any available funds in the City Treasury subject to existing COA rules and regulations;
