A RESOLUTION AUTHORIZING THE CITY GOVERNMENT OF PASIG, THROUGH THE HONORABLE CITY MAYOR, VICTOR MA REGIS N. SOTTO, TO ENTER INTO AND SIGN A MULTI-YEAR CONTRACT FOR CONSULTANCY SERVICES FOR THE FLOOD CONTROL MASTER PLAN AND FEASIBILITY STUDY OF PASIG CITY, AND FOR OTHER PURPOSES.

WHEREAS, to immediately address the flooding problems experienced by the City of Pasig brought about by climate change, inadequate flooding control measures, and an increased population, a master flood-control development plan needs to be formulated to provide a long-term solution on the matter;

WHEREAS, the Master Flood-Control Development Plan and Feasibility Study envision to attain the following major objectives:

1. To formulate a short, medium, and long-term solution for the urban drainage and flooding problems in Pasig City to reduce the adverse effects of flooding on people and property and to protect existing and proposed developments in the area;
2. To establish the flood control master plan, policy, strategy, target design flood magnitude and drainage improvement works, with consideration on adaptation on climate change based on accepted projection;
3. To identify all the possible alternative flood mitigation measures and effective drainage infrastructures based on Integrated Water Resource Management principles while optimizing the effectiveness of the existing drainage system within the area;
4. To incorporate both structural and non-structural flood control measures into the Flood Control Master Plan and Feasibility Study and formulate a flood control project implementation plan; and
5. To prioritize proposed drainage projects considering its environmental, economic, social and technical aspects.

WHEREAS, there is a need to avail of the services of professionals and industry experts to provide dedicated attention to the formulation of a long-term solution given the lack of City Government resources to develop the same within a span of fourteen (14) months divided in two (2) phases from Calendar Year 2023 to Calendar Year 2024 as described more specifically in the Terms of Reference;

WHEREAS, the City Government of Pasig intends to come up with a Master Flood-Control Development Plan by the end of Calendar Year 2024 as seasonal changes need to be considered in the conduct of the related feasibility study;

Sotto, to enter into and sign a Multi-Year Contract for the Consultancy Services for the Flood Control Master Plan and Feasibility Study for Pasig City.

Mr. Presiding Officer and Members of the 11th Sangguniang Panlungsod the Committee on Laws Rules and Internal Government respectfully presents & submits the Committee Report on Proposed Resolution: "A Resolution Authorizing the City Government of Pasig, Through the Honorable City Mayor, Victor Ma. Regis N. Sotto, To Enter Into and Sign a Multi-Year Contract for Consultancy Services for the Flood Control Master Plan and Feasibility Study of Pasig City, and for Other Purposes."

The Committee Respectfully Reports:

The Committee hearing was convened and called to order on 18 July 2023, at 2:00PM in the afternoon.

Discussion

1. The City Government of Pasig evinces its utmost concern for the well-being and safety of its citizens in Proposed No. 331-2023 by which the intent is to enter into and sign a multi-year contract for consultancy services for the flood control master plan and feasibility study of the city. As such, the Officer-in-Charge of DRRMO is asking for the assistance of the city council for the implementation of the project.
2. The said project is planned to be finished within 12 months from the signing of the contract.
3. In the proposed resolution, it was expressed that the DRRMO and all other offices concerned lack the gadgets, equipment, and technical expertise for the execution of the Flood Control Master Plan and Feasibility Study.
4. The timetable and duration of multi-Year contract spans from year 1 that is 01 October 2023 until year 2, 31 September 2024 with a total amount of PHP 35,417,984.00.
 - a. The said total amount was averaged from the 3-4 certified consultancy services which the DRRMO asked for estimates.
 - b. In the breakdown of costs, the amount allotted for year 1 is considerably less than year 2 despite the initial and advance payment being settled in the former. This is due to the fact that Year 1 will commence on October, giving it only 3 months for the year of 2023. Whereas the remaining 9 months will be on 2024, until the month of September.
5. Among the inclusions of the consultancy services that is planned to be availed is a software that simulates, with a certain degree of accuracy, flood risks and incidence in the areas of Pasig which will then significantly contribute and assist in the flood control and management plans of the city government.
 - a. As per the clauses of the contract, at the end of their term, the initial and base software will remain with the city government to utilize. However, the subsequent updates and innovation which it might have

that will further assist in the flood control and management is not included.


- b. With that, the DRRMO seeks to include the subsequent upgrades of the software to keep them up to date with the innovation on the system that will improve the efficiency and effectivity of the execution of the flood control master plan.
 - c. The flood control simulation is just one part of the encompassing and overarching flood control master plan.
6. The City Councilors raised that there is a lack of completion of all the pertinent information and details of the consultancy services including everything that they offer such as the products, services, scope of work, and such.
 - a. Inclusion of the aforementioned in the TOR is crucial so that there will be data to be analyzed, and in order to ensure that the results and effectivity of the project and master plan is properly facilitated.
7. It has been clarified that although the City Government of Pasig has CLIMA which is a software that provides information, historical data, and progress of the city's flood control, management as well as the status quo, there is still a need for the said consultancy services as they include a more advance software for flood simulation.
8. Councilor Quin Cruz elevated his concerns on the feasibility and effectivity of the project given the absence of the pertinent details that are the factors and variables such as the design and inventories of all the waterways and drainages, as well as the rivers and catch basins, and all other pertinent details and technicalities down to the most minute that have to be thoroughly considered and studied first before the formulation of the said master plan and its eventual execution.
 - a. Further, it was manifested that the master plan should be consistent with the existing national plan with the DPWH for uniformity with all the other LGUs and optimum effectivity.
 - i. With respect to this, Councilor Rustia manifested his hope that the national government be encourage to be in close coordination with the LGU of Pasig in executing the master plan for optimum effectiveness and success that eventually leads to a better long-term plan.
 - b. It was manifested as well that the consultancy firm should also consult with all the barangays to collect all the information and pertinent factors such as the data and variables that will help with the formulation of the master plan effectively.
 - i. As such, they should also start with the barangays since the problems are usually within their jurisdiction due to poor planning and execution of drainage systems.

9. It was clarified that there were not any concrete plans formulated or prepared by the previous administration and officers-in-charge in terms of overarching and overall plan for the flood control and management of the city. Nevertheless, there were numerous projects which addresses the problems and risks of flood-prone areas and other flood-related issues:
 - a. Such can be referenced in improving and formulation of the master plan.
 - b. It was also clarified that there is a different sections or departments for flood control and flood maintenance.
10. It was also manifested that the need for consultancy services in the flood control master plan and feasibility study is due to the substantial size of the City of Pasig which exceeds the capacity of the city engineering firm to handle independently.
11. It was clarified that the budget will come from the engineering department as per the AIP. In the event that there will be a shortage in budget, then a supplemental budget will have to be prepared.

Recommendations

1. The City Councilors moved to amend the 6th paragraph of the resolution removing the table breakdown of the total averaged amount of the project implementation as there are uncertainties in the actual amount due to possible unforeseen changes and modifications in the project due to wide range and variety of factors subject to the needs of the project.
2. The City Councilors also moved to amend the resolution by omitting the initial 12-month duration date starting on 01 October 2023 until 31 September 2024, modifying it to last 14 months until 31 November 2024 to give allowance to changes and modifications to the project specifications.
3. The committee recommends that the Proposed Resolution be approved on the next regular session with amendments.




