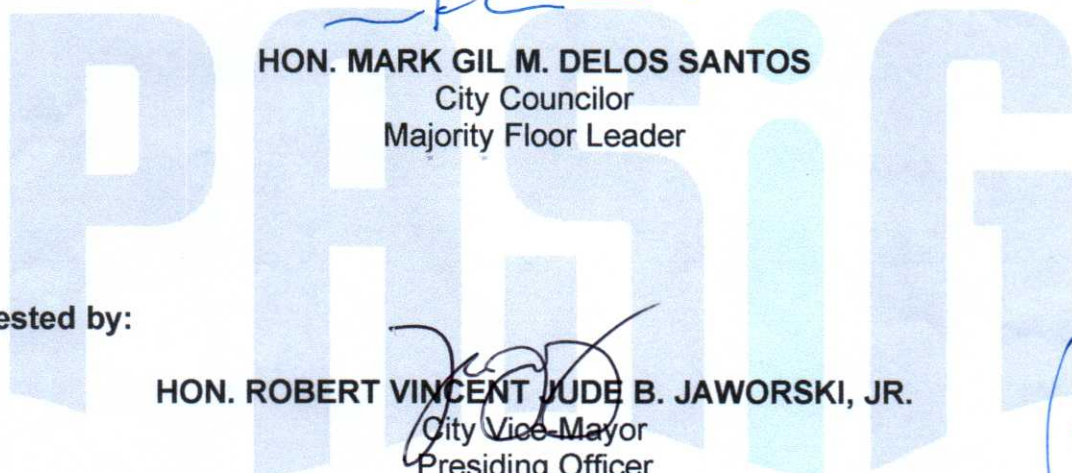

The Committee on Health, Sanitation and Nutrition and the Committee on Education conducted a Joint Committee Hearing on July 26, 2023, 11:00 o'clock in the morning at the Gallery, Session Hall, 7/F Pasig Cityhall, to discuss the pertinent provisions of Proposed Resolution No. 332, Series of 2023 entitled: "A RESOLUTION AUTHORIZING THE CITY GOVERNMENT OF PASIG THROUGH THE HONORABLE CITY MAYOR, VICTOR MA. REGIS N. SOTTO, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT BETWEEN THE CITY GOVERNMENT OF PASIG AND ARELLANO UNIVERSITY FOR THE CONDUCT OF A MIDWIFERY INTERNSHIP PROGRAM IN THE CITY OF PASIG, AND FOR OTHER PURPOSES".

The Joint Committee, upon declaration of Quorum, discussed the content of the Memorandum of Agreement, to wit:

1. The Pasig City Government, through the Pasig City Health Department, operates Barangay Health Centers, Super Health Centers, Center for Dialysis Healthy Lifestyle, Ambulatory Surgery, Maternity Clinic, and New Born Care of Pasig City (CHAMP), and Lying-In Clinics aimed at providing local communities access to maternal and child care, diagnostic facilities, immunization, laboratories, X-Ray and ultrasound;
2. The Arellano University has requested the City Government of Pasig, through the City Health Department, to accept its midwifery students qualified to undergo a clinical practicum to observe and assist in Pasig City Health Centers, CHAMP, and lying-in clinics for their clinical affiliation and training;
3. The City Health Office recommends the partnership as this will augment the manpower complement in our local health centers and lying-in clinics and shall provide invaluable learning and exposure to allied health students;
4. The Officers of Arellano University assured the Committee that their midwifery students will be supervised by Licensed Midwives, pre-screened before deployment, medically fit for the program and with high sense of accountability and accountability for the internship program.

COMMITTEE RECOMMENDATION(S):

It was recommended by both the Committee on Health, Nutrition and Sanitation and the Committee on Education pass Proposed Resolution No. 332-2023 in its second and third and final reading in the next regular session of the Sanguniang Panglungsod.

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This *Memorandum of Agreement* ("Agreement") is made and entered into this _____ day of _____ 2023, in Pasig City, Philippines, by and between:

ARELLANO UNIVERSITY, an educational institution duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal office at 2600 Legarda St., Sampaloc, Manila, herein represented by its Chairman and Chief Executive Officer, **MR. FRANCISCO P.V. CAYCO**, hereinafter referred to as "**ARELLANO**";

and

The **CITY GOVERNMENT OF PASIG**, a local government unit existing under the laws of the Republic of the Philippines, through the **PASIG CITY HEALTH DEPARTMENT**, with office address at Pasig City Hall, Caruncho Avenue, Barangay San Nicolas, Pasig City, herein represented by the City Mayor, **HON. VICTOR MA REGIS N. SOTTO**, and hereinafter referred to as "**PCHD**";

Each a "Party," and collectively the "Parties."

WITNESSETH THAT:

WHEREAS, Section 17 of the Local Government Code of 1991 provides that every local government unit shall exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of health services including the implementation of programs and projects on primary health care, and access to secondary and tertiary health services, among others;

WHEREAS, pursuant to the foregoing mandate, the City Government of Pasig, through the Pasig City Health Department, operates Barangay Health Centers, Super Health Centers, Center for Dialysis, Healthy Lifestyle, Ambulatory Surgery, Maternity Clinic, and Newborn Care of Pasig City (CHAMP), and Lying-in Clinics aimed at providing local communities access to maternal and child care, diagnostic facilities, immunization, laboratories, X-ray and ultrasound, among others;

WHEREAS, the Arellano University has requested the City Government of Pasig, through the PCHD, to accept its midwifery students qualified to undergo a clinical practicum to observe and assist in Pasig City health centers, CHAMP, and lying-in clinics for their clinical affiliation and training;

NOW, THEREFORE, for and in consideration of the foregoing premises, the Parties have stipulated and agreed as follows:

SECTION 1: RESPONSIBILITIES OF THE PARTIES

A. Arellano, through its School of Midwifery, shall:

- 1.1 Submit to the PCHD a certified list of qualified students who are finally selected for admission for affiliation together with their respective health clearances;
- 1.2 Provide for the didactic or theoretical instruction of the student-interns, as required;
- 1.3 Coordinate with the City Health Officer or his designated authorities, regarding the program of affiliation, assignments, training and discipline of Midwifery students, special holidays, convocations and other allied matters.
- 1.4 Designate a Clinical Instructor who will supervise and monitor the proper decorum, attendance, and behavior of the students who are under the internship program;
- 1.5 Assumes the responsibility for the care of the student-affiliates in case of illness, injury, or accidents during the course of affiliation with PCHD; and
- 1.6 Comply with the policies and procedures established by the PCHD for the conduct of the clinical practicum.

B. The PCHD shall:

- 1.7 Agree and allow the affiliation and training in the local Health Centers, CHAMP, and lying-in clinic of the students, subject to the procedures, and guidelines governing affiliation and training of students in all centers accredited by the Department of Health (DOH);
- 1.8 Assist and coordinate in providing the student-affiliates the maximum opportunity to gain experience and training as required by Republic Act No. 7392, or The Philippine Midwifery Act of 2002, and the rules and regulations promulgated by the Board of Examiners for Midwives, and the Civil Service Commission;
- 1.9 Permits the attendance or participation of the student-affiliates in specified activities and special programs of the PCHD;
- 1.10 Enforces rules and regulations regarding the admissions, supervision, training, and grading of student-affiliates as prescribed by the City Health Officer.
- 1.11 Maintain the quality of training within the highest possible level through continuous staff development and concomitant improvement of existing training facilities.
- 1.12 Through its designated authorities and/or representatives, monitor the activities conducted by the student-affiliates designated in various local health centers, CHAMP, and lying-in clinics. The staff of these institutions shall assist, supervise, or act as resource speakers when needed.

SECTION 2: QUALIFICATION, CONDUCT, AND INSTRUCTION OF STUDENT AFFILIATES

- 2.1 Only those included in the certified list of qualified students shall be allowed to participate in the clinical practicum.
- 2.2 A ratio of one (1) Clinical Instructor for every ten (10) student-affiliates shall be strictly observed in every shifting duty during the course of the clinical practicum.
- 2.3 All student-affiliates shall maintain the cleanliness, orderliness and safety of their assigned area.
- 2.4 After every training period of each group, the student affiliates shall submit a narrative report, family care, Analysis/Community Diagnosis/Midwifery Care for evaluation of the training staff in the presence of the concerned health center. In case revisions are to be made, the same shall be submitted within five (5) days.
- 2.5 All student-affiliates shall be governed by the rules and regulations regarding the conduct of training prescribed by the Department of Health.
- 2.6 The student shall remain professional at all times. The PCHD or the designated Super Health Centers authorities shall report any form of misconduct committed by a student during the course of his or her Summer Internship Program in writing addressed to the Arellano authorities for appropriate disciplinary action.
- 2.7 Arellano shall assume full responsibility for the care of the student-affiliates and Clinical Instructors in case of illness or injury during the course of the clinical practicum.
- 2.8 PCHD may immediately terminate the training of a particular student-affiliate, who:
 - 2.8.1 fails to comply with the rules and regulations; or
 - 2.8.2 commits any act of omission detrimental to the health, safety or welfare of the patients, medical, and non-medical staff of Pasig City health centers, CHAMP, and lying-in clinics.

SECTION 3. TERM, TERMINATION, EFFECTIVITY

- 3.1 This Agreement shall commence on the date last signed by a Party and shall be valid until August 2024.
- 3.2 This Agreement may be terminated sooner by either of the Parties upon written notice of at least one (1) month before the effective date of termination.
- 3.2 Any violation committed by a student-affiliate of the rules and regulations as prescribed by the PCHD or the policies and procedures of the local health centers, CHAMP, and lying-in clinics, shall be valid ground for the termination of this Agreement.
- 3.3 The safety and well-being of the patients shall be the paramount concern of the Parties. At no time shall the interest and welfare of the patients be made subordinate to the training of the students. Accordingly, PCHD may terminate this Agreement if it determines that the continuation of the same may be inimical to the

proper functioning of the local health centers, CHAMP, and lying-in clinics, the welfare of its patients, and the progressive training of the students.

SECTION 4. LIABILITY

- 4.1 The Parties hereby acknowledge that the students and clinical instructors assigned by Arellano to attend to the implementation of this Agreement are not employees of the PHCD or any of the local health centers, CHAMP, and lying-in clinics. As such, Arellano assumes full responsibility for the acts and/or omissions of any of the students and clinical instructors.
- 4.2 Arellano shall be liable for and shall hold the PCHD, local health centers, CHAMP, and lying-in clinics free and harmless from any loss or damage that the PCHD, local health centers, CHAMP, and lying-in clinics or any of its executives, officers, medical and non-medical staff, employees or agents, and patients may incur or suffer or held liable or accountable for, arising from or otherwise attributable to any fault or negligence or act of omission of the school or any of its students.
- 4.3 The student shall, at the option of PCHD, either replace the property or reimburse PCHD for the cost or case of loss, breakage or damage to the property, equipment, machineries, supplies and other paraphernalia of the local health centers, CHAMP, and lying-in clinics (centers' properties) as a result of any fault, negligence or act of omission of any of the students. A fine equivalent to the value of the damage done to the property but in no case more than twice its value or the replacement of the property damaged, destroyed, lost or defaced or cleaning of the entire room or wall thereof, free from all marks and writings.

SECTION 5. DATA PRIVACY

- 5.1 The Parties agree that any activity that involves processing of personal data shall comply with Republic Act No. 10173, otherwise known as the Data Privacy Act of 2012, its Implementing Rules and Regulations, and other applicable laws and administrative issuances of the National Privacy Commission.

SECTION 6. AMENDMENTS, REVISIONS

- 6.1 Either Party may request changes to this Agreement. Any changes, modifications, revisions or amendments to this Agreement which have been mutually agreed upon by and between the Parties to this Agreement shall be incorporated by a written instrument, and effective when executed and signed by all Parties.

SECTION 7. COUNTERPARTS

- 7.1 This Agreement may be executed in one or more counterparts, each of which shall be deemed an original, and all of which taken together shall constitute one and the same Agreement.

SECTION 8. SEPARABILITY CLAUSE

- 8.1 Should any provision in this Agreement be found to be invalid or unenforceable by any competent court, the other provisions not so declared shall remain in full force and effect.
