WHEREAS, Presidential Decree No. 15, s. 1972, which created the Cultural Center of the Philippines (CCP), makes it a function of the CCP to "awaken the consciousness of our people to our cultural heritage, and to encourage them to assist in its preservation, promotion, enhancement and development" as well as "to cultivate and enhance public interests in, and appreciations of, distinctive Philippine arts in various fields";

WHEREAS, pursuant to Republic Act No. 7160, or the Local Government Code of 1991, the City Government of Pasig shall ensure and support, among other things, the preservation and enrichment of culture within its territorial jurisdiction;

WHEREAS, in line with the celebration of their respective 450th years, the City Government of Pasig and the Immaculate Conception Cathedral of the Archdiocese of Pasig have agreed to host the CCP's resident symphony orchestra and chorale group, *i.e.*, the Philippine Philharmonic Orchestra (PPO) and the Philippine Madrigal Singers (MADz), for a public concert at the Immaculate Conception Cathedral;

WHEREAS, the CCP has agreed to field the PPO and the MADz for said outreach concert in Pasig City, as it is consistent with its mission to bring the PPO and MADz closer to the Filipino people through outreach concerts, allow their world class artistry to reach a broader audience, and enable Filipino audiences to witness the highly acclaimed performance of the country's premiere orchestra and chorale group;

NOW, THEREFORE, be it resolves, as it is hereby resolved, by the Sangguniang Panlungsod, in regular session duly assembled, to authorize the City Government of Pasig, through the Honorable City Mayor, Victor Ma Regis N. Sotto, to enter into and sign a Memorandum of Agreement with the Cultural Center of the Philippines for the conduct, in Pasig City, of an outreach concert by the Philippine Philharmonic Orchestra and the Philippine Madrigal Singers, and for other purposes;

RESOLVED, FURTHER, that the Secretary of the Sanggunian Panlungsod furnish all concerned agencies/offices copies of this Resolution, as duly adopted/approved by the Sanggunian Panlungsod.




