The ELA supports existing planning processes of the City and complements the Comprehensive Development Plan (CDP), Comprehensive Land Use Plan, and is anchored on the City's national and international commitments;

WHEREAS, after evaluation, the members of this Body decided to approve and adopt the Executive-Legislative Agenda for Fiscal Year 2023-2025 as it reflects the priority agenda of both the executive and legislative departments based on the CDP process and is aligned with national priorities and thrusts;

NOW, THEREFORE, upon motion duly seconded by all members present, the Sangguniang Panlungsod, resolves, as it is hereby resolved, to approve and adopt the Executive-Legislative Agenda for Fiscal Year 2023-2025 of the City of Pasig.
