A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, VICTOR MA REGIS N. SOTTO, TO GRANT CASH AWARDS THROUGH THE FINANCIAL INCENTIVE PROGRAM OF THE CITY GOVERNMENT OF PASIG TO COLLEGE AND TECHNICAL (TWO-YEAR PROGRAM) LEVEL - STUDENTS OF PASIG WHO ARE GRADUATING WITH HONORS.

**WHEREAS**, the 1987 Constitution provides that the State shall establish and maintain a system of scholarship grants, student loan programs, subsidies and other incentives which shall be made available to deserving students in both public and private schools, especially to the underprivileged;

**WHEREAS**, the City of Pasig firmly believes that completion of a higher academic degree or a technical vocational course significantly improves the chances of a person for a better quality life in the future;

**WHEREAS**, the City of Pasig is also committed to promote academic excellence through the provision of cash incentives to students who are residents of Pasig City and graduating from CHED accredited Higher Education Institutions (HEIs) with honors such as summa cum laude, magna cum laude and cum laude as well as technical-vocational students who are completing their two-year programs with honors or distinction such as recipients of gold or silver medals;

**WHEREAS**, the cash grants shall serve as further encouragement for these successful graduates and completers in finding good jobs and/or preparing themselves in the transition from school to work;

**WHEREAS**, upon careful deliberation the following cash incentives are deemed appropriate to be awarded to the Pasigueños who are graduating with honors:

Summa Cum Laude	= P30,000.00
Magna Cum Laude	= P25,000.00
Cum Laude	= P20,000.00

While those who are finishing their two-year technical-vocational programs shall be receiving the following:

Gold medal or equivalent	= P10,000.00
Silver medal or equivalent	= P 5,000.00

**NOW, THEREFORE**, in session duly assembled, be it resolved, as it is hereby resolved, to authorize the Honorable City Mayor, Victor Ma Regis N. Sotto to grant Cash Awards through the Financial Incentive Program of the City Government of Pasig to College and Technical-Vocational (two-year program) Level - Students of Pasig who are Graduating with Honors.
